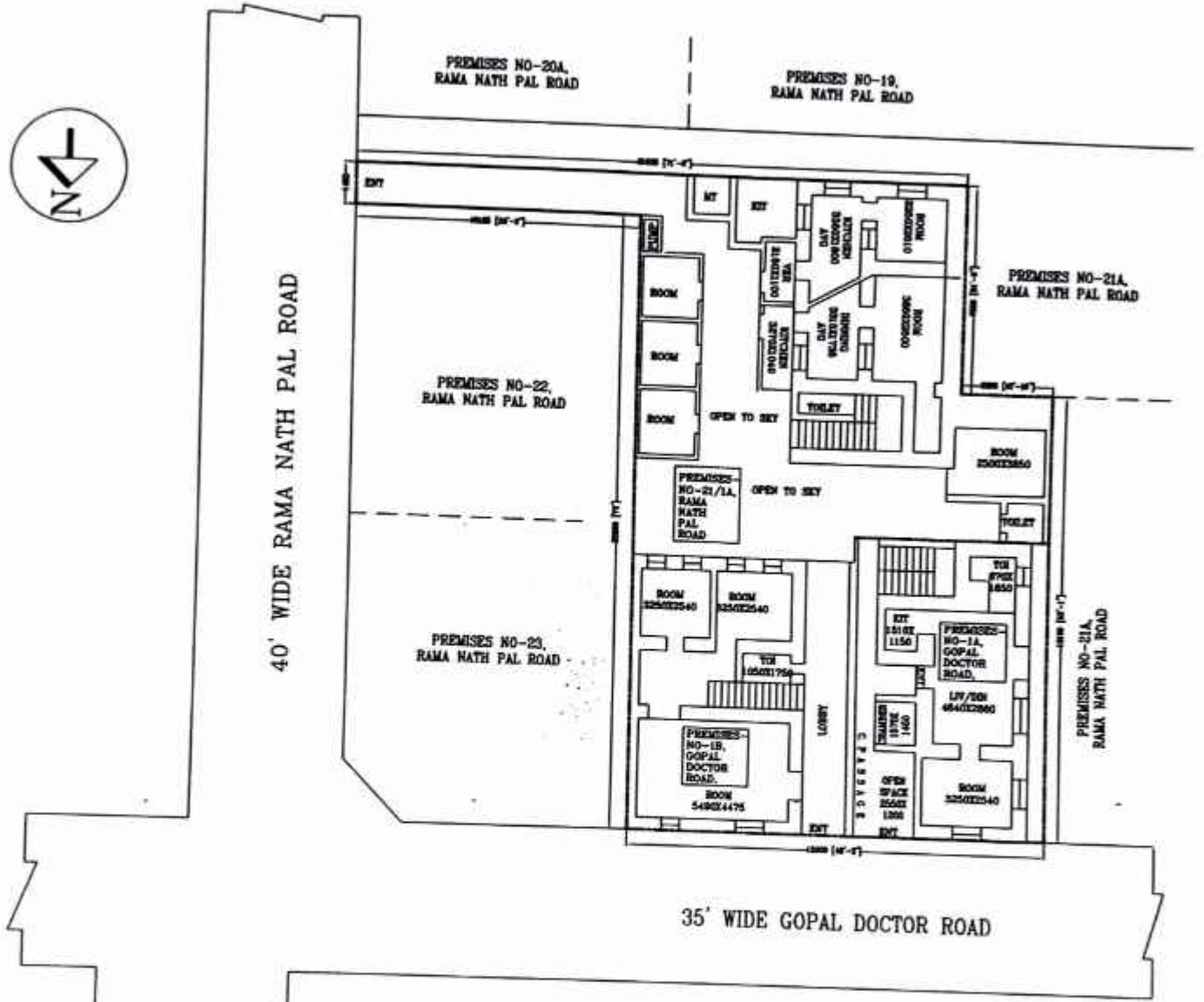

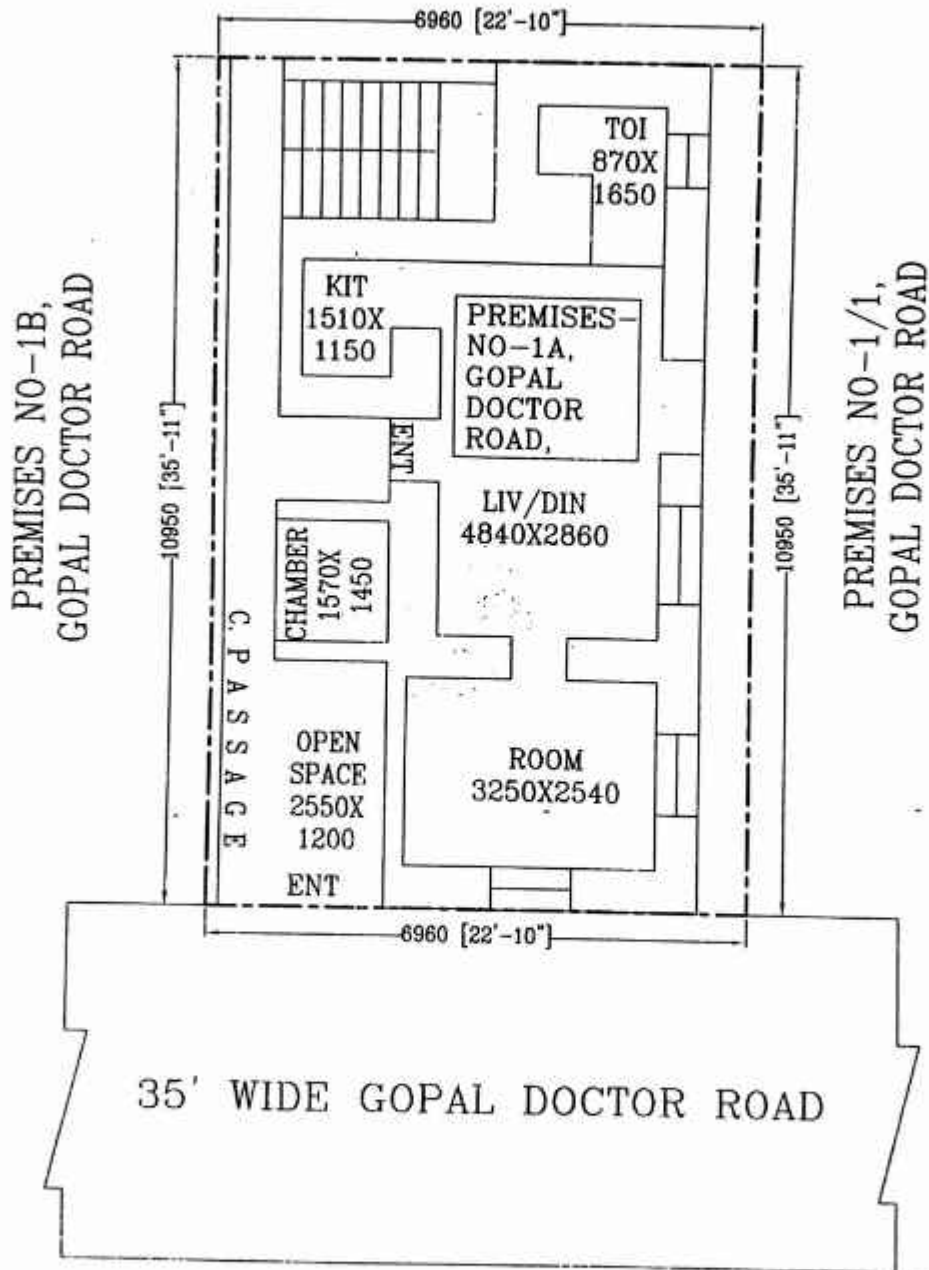

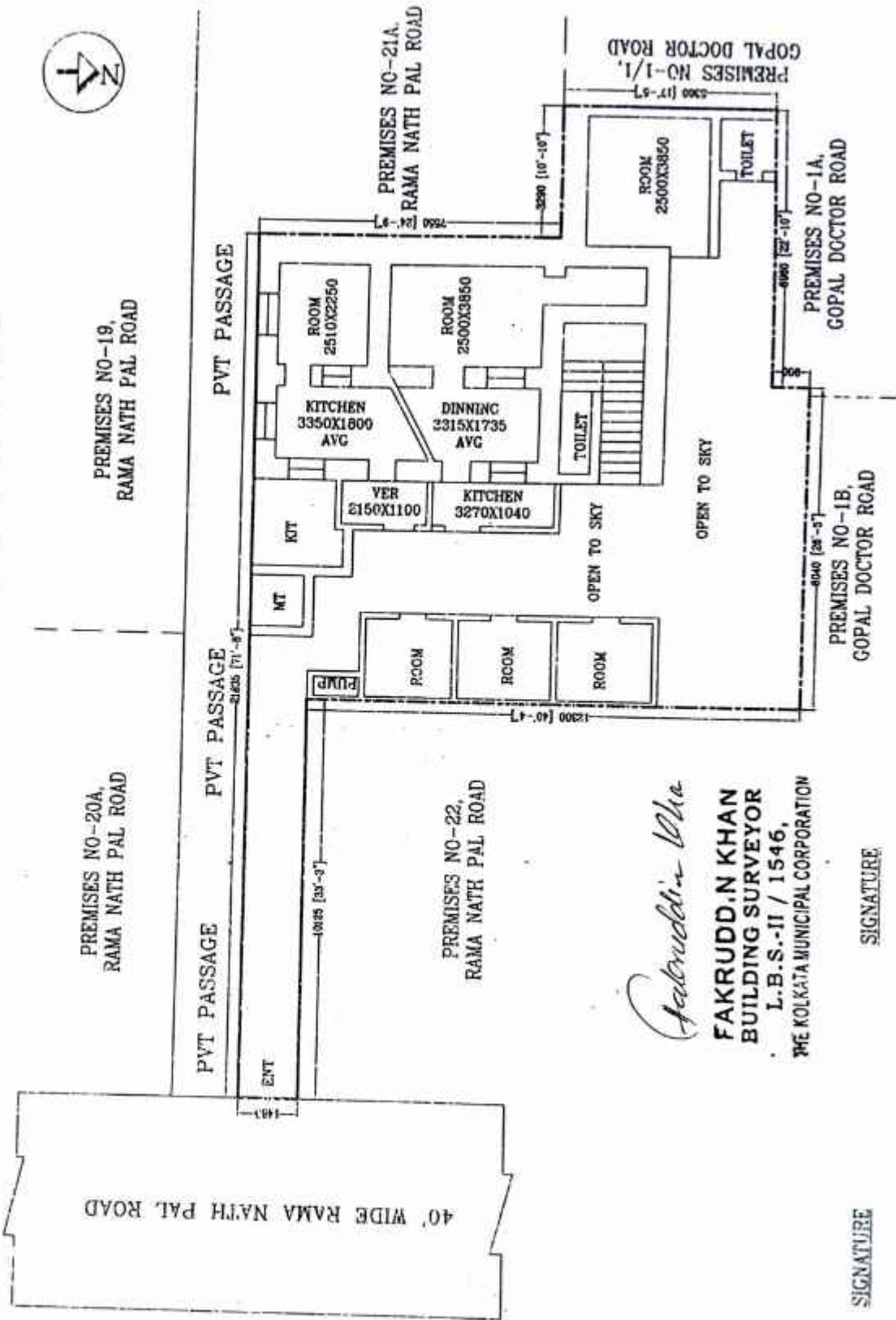
BEFORE AMALGAMATION PLAN

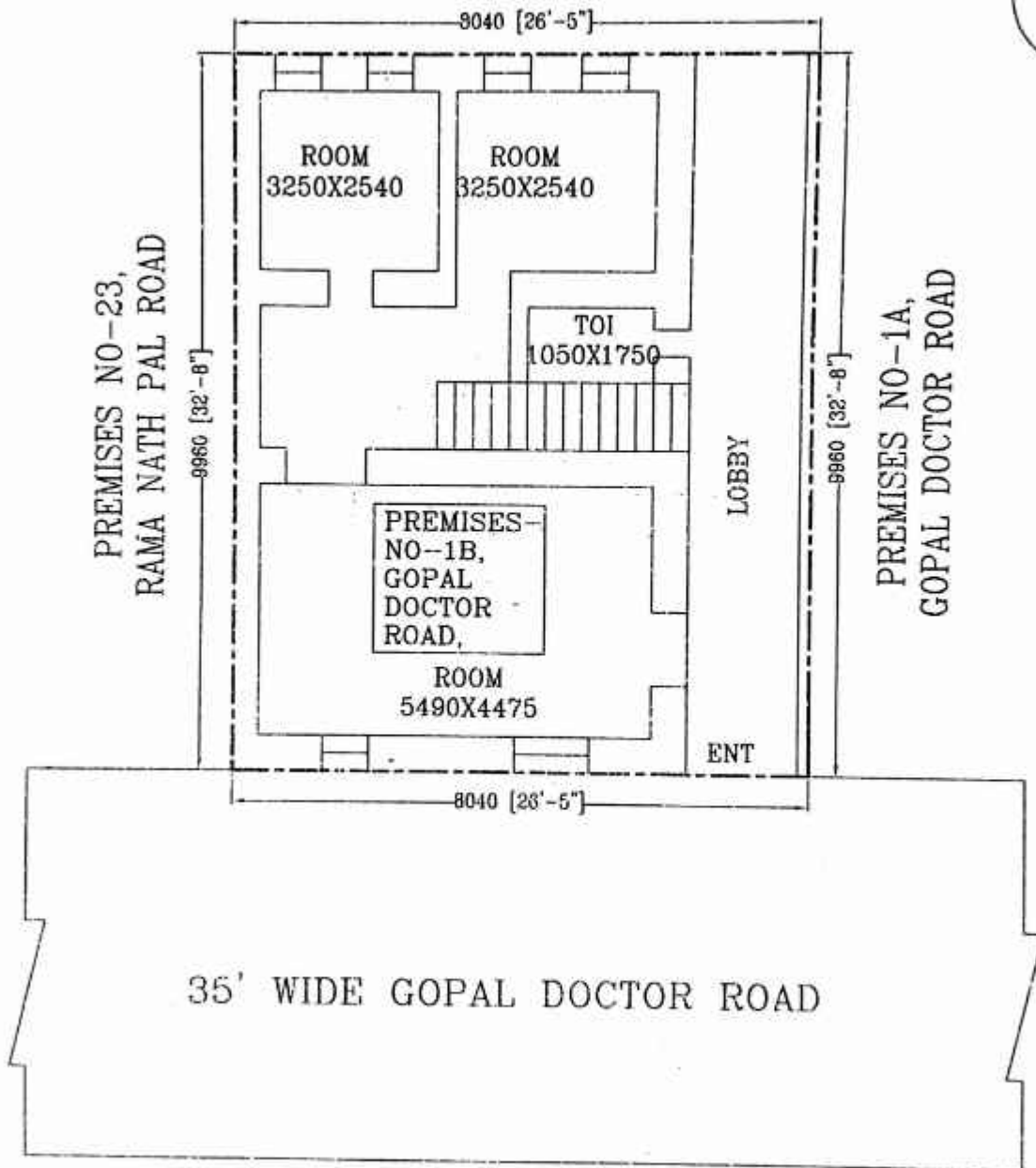
