I hereby revoke all my previous wills and testamentary dispositions of any and declare this to be my last will and testament

I appoint my father Janki Ram Shastri and if he predeceases me, my wife Smt. Ram Bular Devi to be sole executor or executrix and trustee of this my will.

I have two sons namely Dittala Prasad Jayswal and Koli Prasad Jayswal and three daughters namely Premalata, Keera and Asha. All my sons and daughters are minors and all the said three daughters are unmarried.

I appoint my father Janki Ram Shastri and if he predeceases me, my wife the said Ram Bular Devi as sole testamentary guardian of my said sons and daughters.

I direct my executor and trustee to maintain my said sons Dittala Prasad Jayswal and Koli Prasad Jayswal and my other son or sons who may be born unto me and my said



daughters Premalata, Neera and the  
entire leg are and my other daughters  
daughters are may be born into me -  
respectively married and to each and ex-  
pense of such maintenance including education &  
medical expenses out of my estate  
I direct my executor and trustee  
to spend a sum not exceeding Rs. 10,000/- -  
(Rupees ten thousand) towards the expenses  
of marriage and costs many expenses of -  
and of my said daughters.

I give devise and bequest -  
a sum of Rs. 150/- (Rupees one hundred and  
fifty) for moiety to my wife the said Ram  
Rani Nani during the term of her natural  
life in lieu of her maintenance. Provided  
nevertheless that if my said wife remarries  
then she enjoy in her former state estate,  
bequest or proceeds of give devise -  
and bequest and my properties of whatever
