KRISHNA BUILDCON, a Partnership Firm, (PAN: AAXFK7234R) having its office at Metro Heights, 1st Floor, Back-side, P.S. Bhaktinagar, District Jalpaiguri, represented by its Partner, SRI DIPAK MUNDHRA, son of Sri Bijay Kumar Mundhra, ((PAN: ACHPM4147P Aadhar No. 5917 9711 7075), Hindu by Religion, Indian by Nationality, Business by Occupation, Resident of 3rd Floor Plot 9, Panchwati Housing Complex, P.O Sevoke Road, P.S Bhaktinagar, District Jalpaiguri, in the State of West Bengal --hereinafter referred to as the "DEVELOPER/CONFIRMING PARTY" (which name and expression shall unless excluded by or repugnant to the context be deemed to include its Partners, office-bearers, executors, successors, representatives, administrators and assigns) of the "THIRD PART".

That in consideration of a sum of Rs......./- (Rupees/- (Rupees/- Only). paid by the Purchaser/s to the Vendors/Developer, the receipt of which is acknowledged by the Vendors/ Developer by execution of these presents and grants full discharge to the Purchaser/s from the payment thereof and the Vendors/Developer do hereby convey and transfer absolutely the Schedule -B property, to the purchaser/s who will/shall now HAVE AND HOLD the same absolutely and forever free from all encumbrances and charges subject to the payment of proportionate rent, etc. to the Govt. of West Bengal.

- 6. That the Vendors/Developer does hereby covenant with the purchaser/s that the tenancy rights under which the Schedule-A property is held by the Vendors/Developer under the superior landlord the State of West Bengal is good and effectual and the interest which the Vendors/Developer proposes to transfer subsists and the Vendors/Developer have full right and authority to transfer the SCHEDULE-B property to the Purchaser/s in the manner as aforesaid and the PURCHASER/S shall hereinafter peacefully and quietly possess and enjoy the Schedule-B property without any obstruction or hindrance whatsoever.
