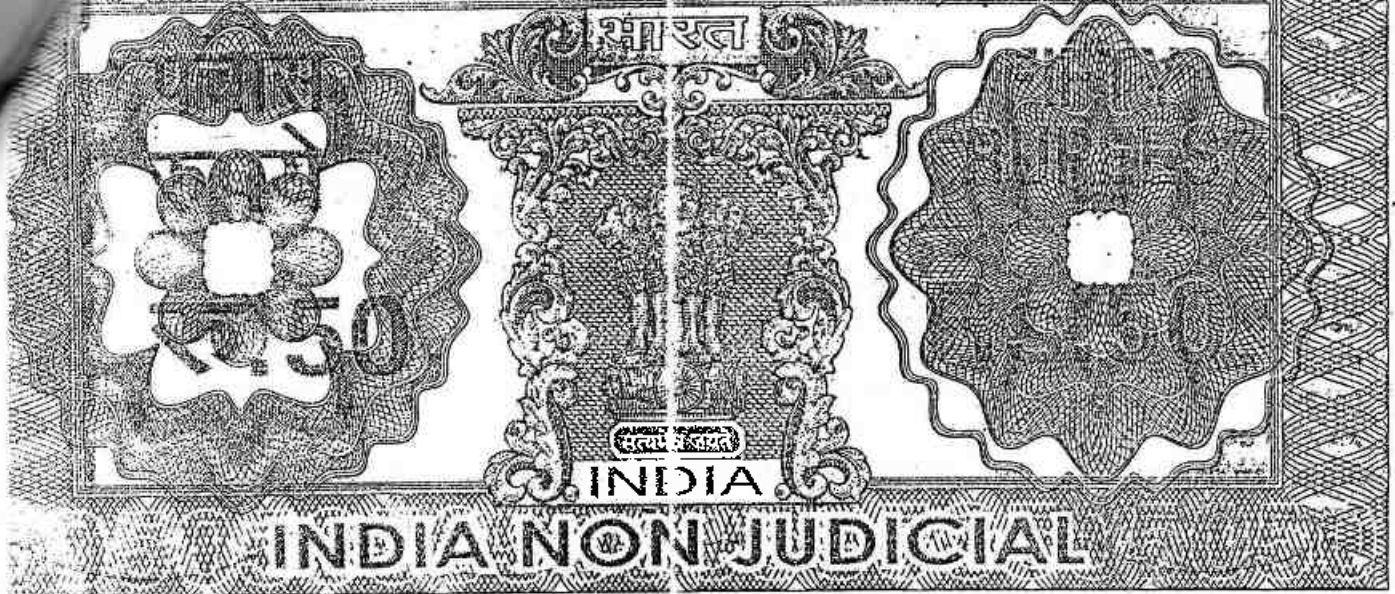

WHEREAS:

- A. By an Indenture dated 8th January, 1970, hereinafter referred to as "the SAID DEED OF TRUST" made between one Bimal Kumar Chatterjee, Smritikona Chatterjee, Kishore Chatterjee, Alok Chatterjee, Sailendra Kumar Chatterjee, Surath Kumar Chatterjee and Monindra Kumar Chatterjee, therein collectively referred to as the Settlers of the One Part and (Smt.) - B. The said Sailendra Kumar Chatterjee, a Hindu governed by the Dayabhaga School of Hindu Law, died intestate in the year 1998 leaving behind him surviving his only daughter namely (Smt.) Rejina Chatterjee as his only heiress and legal representative. His wife Late Ira Chatterjee had died in or about the year 2016.
- C. The said Surath Kumar Chatterjee, a Hindu governed by the Dayabhaga School of Hindu Law, died intestate on 05th October, 2009, leaving behind him surviving his only son namely, Tridib Chatterjee as his only heir and legal representative. His wife, Late Kanika Chatterjee had died on February 09, 2011.
- D. The said Monindra Kumar Chatterjee, a Hindu governed by the Dayabhaga School of Hindu Law, died intestate on 3rd May, 1996, leaving behind him surviving his two sons namely and Rajib Chatterjee as his only heirs and legal representatives. His wife Late Madhabi Chatterjee had died on 30th May, 2006. One of his son Sanjib Chatterjee died on 18th May, 2016.
- E. The said Sanjib Chatterjee, a Hindu governed by the Dayabhaga School of Hindu Law, died intestate on 18th May, 2013, leaving him surviving his widow namely, (Smt.) Tanuka Chatterjee, his only son namely Shaunak Chatterjee and his only daughter namely, (Smt.) Sneha Chatterjee as his only heir heiresses and legal representatives.
- F. Presently, Kishore Chatterjee is the only surviving Settlor under the said Deed of Trust and the said Trust is still valid subsisting and in full force and effect.
- G. On or about 12th January, 2017 the said (Smt.) Smritikona Chatterjee, a Hindu governed by Dayabhaga School of Hindu Law died intestate leaving behind her surviving her two sons, Kishore Chatterjee and Alope Chatterjee as her only heirs and legal representatives;
- H. On or about 20th August, 2017 the said Alope Chatterjee, a Hindu governed by Dayabhaga School of Hindu Law died intestate leaving behind him surviving his wife, Smt. Binati Chatterjee and his two sons, Arindam Chatterjee, and Arijit Chatterjee as his legal heirs and heiress of the legal representatives.
- I. In the circumstances stated above, both the original trustees namely, (Smt.) Smritikona and Monindra Kumar Chatterjee having died, there is no surviving trustees of the said trust estate.
