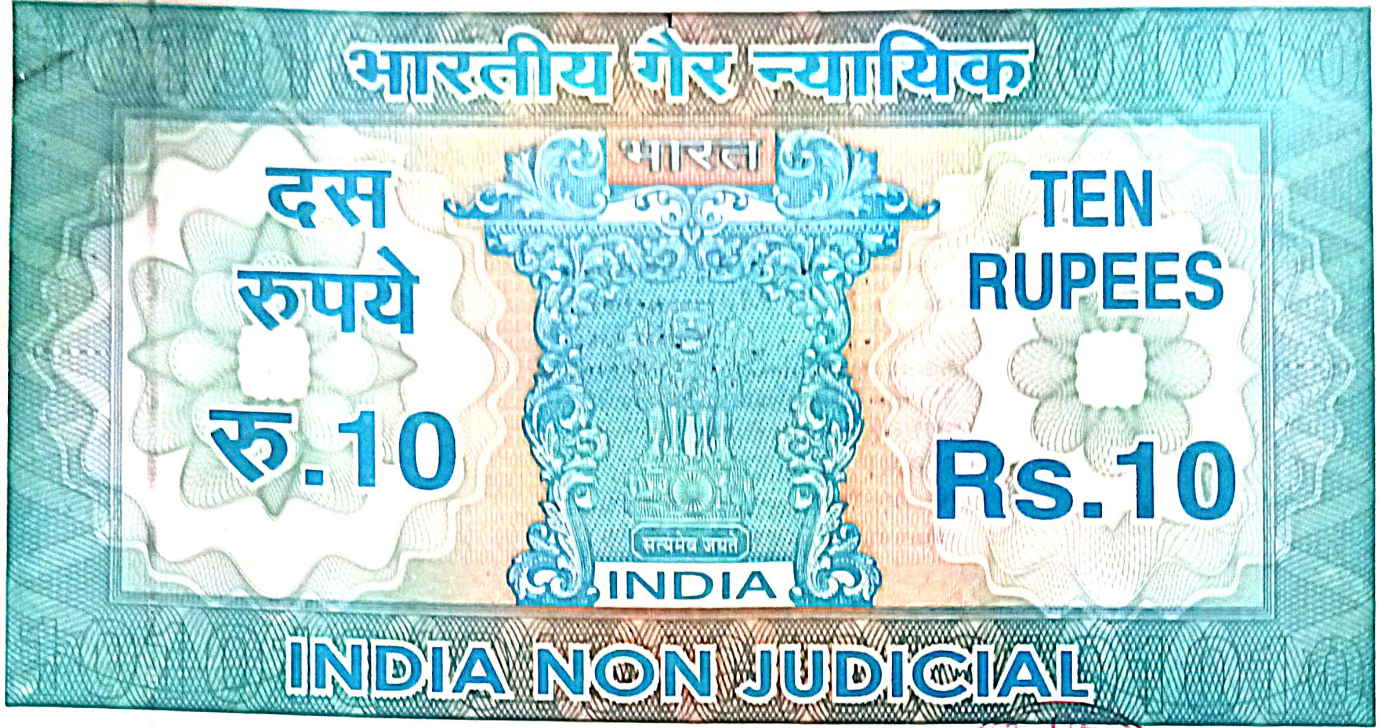
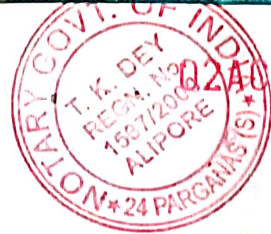

1. That, the Land owner namely SRI SOUMEN GHOSH, son of Late nilmony Ghosh, by faith Hindu, by Nationality Indian, by occupation Business, residing at V-1/3, Kamdahari, P.O. Garia, P.S. Banskroni, Pincode- 700084, District- South 24 Parganas, has a legal title to the land i.e. "MAYER BHUBAN" situated at Premises No. 176, Gostatala, Mouza- Kamdahari, J.L. No. 49, R.S. No. 200, Pargana Magura, District Collectorate Touzi No. 14, comprised in R.S. Khatian No. 772 corresponding to L.R. Khatian No. 1760 appertaining to R.S. and L.R. Dag No. 483, Police Station previously Regent Park now Banskroni, Pincode-700084, under the limit of the Kolkata Municipal Corporation Ward No. 111 vide KMC Assessee No. 31-111-09-0176-1, District South 24 Parganas, on which the Development of the project is to be carried out

That, I / Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That, I / Promoter shall take all the pending approvals on time from the competent authorities.
- 9. That, I / Promoter have/has furnished such other documents as have been prescribed by the rule and regulations made under the Act.
- 10. That, I / Promoter shall not discriminate against any allottee at the time of allotment of any apartment, flat or building, as the case may be, on any grounds.

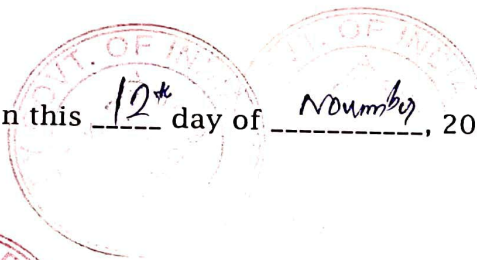
