WHEREAS the land described below measuring 5 Kathas originally belonged to one Sarat Chandra Burman, who transferred the same by way of lease to one Sri Jagadish Chandra Sarkar of Siliguri by means of a registered deed of Lease and while so possessing he sold the said land to Monoranjan Saha, Sri Kanai Lal Saha and Sri Kasinath Saha jointly by virtue of a deed of sale registered on 12.6.64 who began to possess the same. While so possessing as owner Monoranjan Saha and others sold the said land described in the schedule given below to Sri Abami Mohon Paul (predecessor in interest of the above named parties - Donors & Donees) by virtue of a deed of sale registered on 17.4.71, who remained in possession of the land till the middle of 1985 when he died . He constructed some constructions for residential purpose on a part of the said land keeping the rest vacant. He died leaving the Donors and the Donees as heirs who inherited the property jointly. Thereafter by amicable arrangement and partition the Donors have been possessing the vacant half portion of the said land and the Donees have been occupying the other part with construction . The Donors have been living separately from the Dongees in mess and property since some time after the death of their father . They have expressed their intention to give up their half portion of the land (vacant) in favour of the Donees as they feel it unnecessary to keep the land for any purpose.

AND Mwhereas the Donors and the Donees are brothers and sisters and affectionate and truthful to each other and each has a great feeling, sentiment and understanding to and for the other and the Donors and the Donees are cooperative to each other in various sphere of life and in time of need,

NOW as a token of love and affection the Donors doth hereby bestow upon and make a gift and absolutely give away all that piece or parcel of land to the DONEES, fully described below in the schedule. The said Donees from this day will and shall become the absolute owner of the below mentioned land and the Donors will and shall cease to have any right, title and interest and possession in or upon the donated property from this day. The Donors doth deliver and made over the actual possession of the aforesaid property to the Donnees absolutely and the Donees have taken delivery of possession thereof from the Donors. The Donees hereafter shall and will

will exercise all their rights in, upon and over the property hereby gifted this day.

It is covenanted that the Donees shall possess the property and enjoy the same hereby gifted peacefully and quietly for all times to come through generations, with all powers of transfer or disposal without any claim or demand from the side of the Donees or their successors or legal representatives and if such claim or demand in future by the Donees or their successors, shall never be entertained and rejected by all courts of law.

The Donees will be fully entitled to mutate their names in the records of the superior landlords- State of West Bengal - in place of the Donors.

The Donees further covenants with the Donees that the property hereby gifted is free from any encumbrance whatsoever or mortgage and the same is in their khas possession
