





1. (a) **Sri Debes Kumar Misra(PAN: BOGPM6025J)**, son of Late Maheswar Mishra, by faith hindu, by occupation -Advocate residing at 69/1, Baghajatin Place, Post Office Baghajatin, Police Station Patuli Kolkata-700086, (b) **Sri Kumar Chandra Kar(PAN:AHRPK3122H)**, son of Late Hare Krishna Kar, residing at 129/8, Purbachal Kalitala Road, P.O. Haltu, P.S. Garfa, Kolkata – 700078, has a legal title to the land on which the development of the proposed project is to be carried out

AND

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances.

3. That the time period within which the project shall be completed by us/promoter is 31/03/2027.

4. That seventy percent of the amounts realised by us/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.


5. That, the amounts from the separate account to cover the cost of the project shall be withdrawn in proportion to the percentage of completion of the project.

That, we / promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.


8. That, we / promoter shall take all the pending approvals on time from the competent authorities
