- 4) That the permission is without prejudice to the Urban Land (Ceiling and Regulation) Act 1976(33 of 1976).
- 5) That the permission is without prejudice to the W.B. Town and country (planning and Development) Act 1976 (W.B. Act. XIII of 1976).
- 6) That the permission is without prejudice to the provision of section(3) of section 6 of WBEA Act 1953 (W.B. Act 1 of 1954).
- 7) That the permission will take effect from the date of issue of such order.
- 8) That where the land is situated within an urban agglomeration within the meaning or the Urban Land (Ceiling and Regulation) Act, 1976 the permission without prejudice to any of the said Act.
- 9) This order is issued subject to approval/permission/license from an appropriate authority if necessary. This order directing regularization of such change, conversion or alteration is subject to obtaining such approval or permission or license from such authority as soon as the order directing regularization of such change, or conversion of alteration as sought for is made.
- 10) This order is subject to ratification of any court's order.
- 11) That the applicant/proprietor will apply to the Govt. for long term settlement of the above land under usual terms & conditions, if in future the land is found to be vested in the state.
- 12) If the land is found already acquired subsequently, this certificate will be treated as void *ab initio*.
