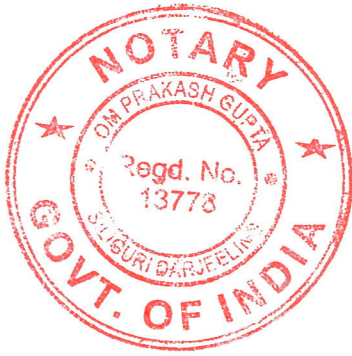

Affidavit Cum Declaration
