Two Thousand Thirteen BETWEEN (1) SRI GOPAL PRASAD JAISWAL, (2) SRI NAND LAL JAISWAL, both sons of Late Durga Prasad Shaw, both by Caste Indian Hindu, both by occupation - Business, both are residing at 35A, Ghosh Lane, Police Station Amherst Street, Kolkata -700006; (3) SMT. MALTI DEVI JAISWAL, wife of Sri Indra Pal Jaiswal, daughter of Late Durga Prasad Shaw, residing at 175, Manicktala Main Road, P.S.Phoolbagan, Kolkata -700054; (4) SMT. MALA SHAW, wife of Sri Ram Ashis Shaw, daughter of Late Durga Prasad Shaw, residing at 33, Balaram Bose 1st Lane, P.S. Bhawanipur, Kolkata -700020, both are by cast Indian Hindu, both by occupation - Housewife, hereinafter collectively called the **DONORS** (which term of expression shall unless excluded by or repugnant to the context be deemed to mean and include their respective heirs, executors, administrators, legal representatives and assigns) of the **ONE PART**.

No. 2, R.S. No.140, Touzi No.2998, comprised in C.S.Dag Nos. 3894 & 5178, corresponding to R.S. No.140, Touzi Nos.2998 & 125B/1, comprised in C.S.Dag Nos. 3890,3895 & 3888, corresponding to R.S. Dag Nos.2907, 2912 & 2905, , under C.S.Khatian No.962, R.S.Khatian Nos. 2737(P), 2710(P), 2711 & 2712, Police Station –Rajarhat, in the District of 24-Parganas (North), by virtue of a registered Bengali Saff Bikry Kobala which was registered on 24.02.1960 in the office of the S.R.Cossipore Dum Dum and therein recorded in Book No.I,Volume No.31, Pages No. 97 to 100, Being No.1478, for the year 1960.

AND WHEREAS Sudama Devi, since deceased, wife of Durga Prasad Shaw, purchased from Sri Krishna Mohan Ghosh ALL THAT the piece and parcel of Sali land measuring an area of 5(Five) sataks more or less equivalent to 3(Three) Cottahas more or less lying and situated at Mouza - Gopalpur, J.L. No. 2, R.S. No.140, Touzi No.2998, comprised in C.S.Dag Nos. 3896, corresponding to R.S. Dag No.2913, under C.S.Khatian No.1561, R.S.Khatian Nos. 1105, Police Station - Rajarhat, in the District of 24-Parganas (North), by virtue of a registered Bengali Saff Bikry Kobala which was registered on 12.08.1960 in the office of the S.R.Cossipore Dum Dum and therein recorded in Book No.I, Volume No.92, Pages No. 233 to 235, Being No.6825, for the year 1960.

AND WHEREAS Sudama Devi, since deceased, wife of Durga Prasad Shaw, purchased from Abdul (Abdur) Rahim Mondal & Others ALL THAT the piece and parcel of Sali land measuring an area of 42(Forty-two) sataks more or less equivalent to 3(Three) Cottahas more or less lying and situated at Mouza - Gopalpur, J.L. No. 2, R.S. No.140, Touzi No.2998, comprised in C.S.Dag Nos. 3877 & 3892, corresponding to R.S. Dag Nos.2894 & 2909, under R.S.Khatian Nos. 1710 & 1714, Police Station - Rajarhat, in the District of 24-Parganas (North), by virtue of a registered Bengali Saff Bikry Kobala which was registered on 22.12.1965 in the office of the S.R.Cossipore Dum Dum and therein recorded in Book No.I, Volume No.142, Pages No. 206 to 211, Being No.10287 for the year 1965.

AND WHEREAS Sudama Devi, since deceased, wife of Durga Prasad Shaw, purchased from Jamat Ali Gazi ALL THAT the piece and parcel of Sali land measuring an area of 12(Twelve) sataks more or less lying and situated at Mouza - Gopalpur, J.L. No. 2, R.S. No.140, Touzi No.2998, comprised in C.S.Dag No. 3895, corresponding to R.S. Dag No.2912, under C.S.Khatian No.962, Police Station - Rajarhat, in the District of 24-Parganas (North), by virtue of a registered Bengali Saff Bikry Kobala which was registered on 17.12.1964 in the office of the

S.R.Cossipore Dum Dum and therein recorded in Book No.1, Being No.9760 for the year 1964.

AND WHEREAS while seized and possessed of the aforesaid properties purchased by her and all of which were analogous to one another, so that the same taken together because one composite property the said Sudama Devi gifted or sold off a large portion thereof and thereafter died on 05.07.2008, intestate, leaving behind her husband namely Durga Prasad Shaw, 4(Four) sons namely Sri Nand Lal Jaiswal, Sri Ananda Lal Jaiswal, Sri Umesh Chand Jaiswal alies Umesh Chandrfa Jaiswal, Sri Gopal Prasad Jaiwal and 4 (four) daughters namely Smt.Shakuntala Jaiswal, Smt.Sarda Bhagat, Smt.Mala shaw, Smt.Malti Jaiswal as her only 9 legal heirs and successors to inherit of the aforesaid property in terms of The Hindu Succession Act.

AND WHEREAS while seized and possessed of the aforesaid composit property the said Durg Prasad Shaw , Sri Nand Lal Jaiswal, Sri Anand LalJaiswal, Sri Umesh Chand Jaiswal alies Umesh Chandra Jaiswal, Sri Gopal Prasad Jaiswal, Smt.Shakuntala Jaiswal, Smt.Sarda Bhagat, Smt. Mala Shaw, Smt.Malti Jaiswal were in possession of the land and due to difficulty in joint possession they executed a Registered Deed of Partition which was registered on 23.02.2009 in the office of the A.D.S.R.O. Bidhan Nagar (Salt Lake City), and therein recorded in Book No.1, C.D. Volume No.2, Pages No. 10644 to 10684, Being No.1637, for the year 2009 and after such partition Durga Prasad Shaw seized and possessed his respective plot No.'I' of land measuring an area 2(two) Cottahs 8(Eight) Chittacks in C.S. Dag No.3892, R.S.Dag No.2911, 4(Four) Chittacks in C.S. Dag No.3892, R.S.Dag No. 2909 and 3(Three) Cottahs 8(Eight) Chittacks in C.S. Dag No. 3888, R.S. Dag No. 2905, under C.S.Khatian No.361,R.S.Khatian Nos. 491 & 3186, aggregating 6(six) Cottahs 4(Four) Chittacks more or less lying and situated at Mouza-Gopalpur, J.L.No. 2,R.S.No. 140, Touzi Nos.2998 & 125B/1, Police Station – Rajarhat at present Airport, in the District of 24 Parganas(North).

AND WHEREAS Durga Prasad Shaw thereafter died intestate on 08.03.2013, leaving behind him his legal successors heirs four sons namely Sri Nand Lal Jaiswal, Sri Anand Lal Jaiswal, Sri Umesh Chand Jaiswal alies Umesh Chandra Jaiswal, Sri Gopal Prasad Jaiswal and 4(Four) daughters namely Smt.Shakuntala Jaiswal, Smt.Sarda Bhagat, Smt. Mala Shaw, Smt.Malti Jaiswal as his only eight legal heirs and successors to inherit the under scheduled properties in terms of Hindu Succession Act.

AND WHEREAS four sons and four daughters of Late Durga Prasad Shaw were collectively the bonafide legal owners of 2 Cottahs 8 Chittacks of land in C.S. Dag No. 3892, R.S. Dag No.2911 and 4 Chittaks of land in C.S, Dag No.3892 R.S. Dag No.2909 and 3 Cottahs 8 Chittaks of land in C.S. Dag No.3888, R.S. Dag No.2905, aggregating 6 Cottahs 4 Chittaks of land more or less, lying at Mouza-Gopalpur, J.L.No. 2, R.S.No. 140, Touzi Nos.2998 & 125B/1, Police Station – Rajarhat at present Airport, in the District of 24 Parganas(North), Scheme Plot No. – I mentioned in Partition Deed, and are enjoying the same peacefully with good right and full power of ownership and without any interruption from any corners have an every right to transfer the same by way of Gift and/or sale to anybody in anyway.

AND WHEREAS since then the Donors herein is seized and possessed of and/or otherwise well and sufficiently entitled to land measuring an area of 2 Cottahs 8 Chittacks of land in C.S. Dag Nos. 3892, R.S. Dag No.2911 and 4 Chittaks of land in C.S. Dag No. 3892, R.S. Dag No.2909 and 3 Cottahs 8 Chittaks of land in C.S. Dag No. 3888, R.S. Dag No.2905, aggregating 6 Cottahs 4 Chittaks of land more or less, lying at Mouza Police Station – Rajarhat at present Airport, in the District of 24 Parganas(North), Scheme Plot No. – I mentioned in Partition Deed, and are enjoying the same peacefully with good right and full power of ownership and without any interruption from any corners together with right to sell and /or gift the same to other as the Donors shall think it fit and proper.

AND WHEREAS the Donee herein is the ^{full blood} own brother of the Donors herein and the Donors herein have great love, affection and confidence upon the donee herein now and donors hereby decided to voluntarily gift and transfer their aforesaid property unto in favour of the Donee herein being ALL THAT piece and parcel of a plot of land 1 Cottah 4 Chittaks out of 2(two) Cottahs 8 Chittaks in C.S. Dag No.3892, R.S. Dag No.2911 and 2 Chittaks out of 4 Chittaks in C.S. Dag No.3892, R.S. Dag No.2909 and 1 Cottah 12 Chittaks out of 3 Cottahs 8 Chittaks in C.S. Dag No.3888, R.S. Dag No.2905 as their 4/8th share out of 6 Cottahs 4 chittaks be the same a little more or less, lying and situated at Mouza-Gopalpur, Police Station – Rajarhat at present Airport, in the District of 24 Parganas(North) within the local limits of Rajarhat Gopalpur Municipality, under Ward No. 3, A.D.S.R.O. Bidhan Nagar (Salt Lake City), in the District of North 24-Parganas, free from all sorts of encumbrances and the donee hereby has accepted this Deed of Gift.

AND WHEREAS the property hereby gifted is valued at or about Rs.5,80,000/- (Rupees Five Lac Eighty Five Thousand only).

NOW THIS INDENTURE WITNESSES that in consideration of the natural love and affection which the Donors had and still has for the Donee, the donors doth hereby grant, gift, transfer, and assure unto and to the use of the Donee freely and voluntarily ALL THAT piece and parcel of a plot of land measuring an area of 1 Cottah 4 Chittaks in C.S. Dag No.3892, R.S. Dag No.2911, 2 Chittaks in C.S. Dag No. 3892, R.S. Dag No.2909 and 1 Cottah 12 chittaks in C.S. Dag No. 3888, R.S. Dag No.2905, under C.S. Khatian No.361, R.S. Khatian Nos. 491 & 3186, aggregating 3 Cottahs 2 Chittaks be the same a little more or less, lying and situated at Mouza-Gopalpur, Plot No. 1, Police Station – Rajarhat at present Airport, in the District of 24 Parganas(North) within the local limits of Rajarhat Gopalpur Municipality, under Ward No. 3, A.D.S.R.O. Bidhan Nagar (Salt Lake City), in the District of North 24-Parganas, morefully and clearly described in the Schedule herein below so as to be entitled to exercise all the right incidental to such ownership

and to exclusive possession of the said property as aforesaid without any hindrance or interference from the Donors or any person claiming through under or in trust for him TOGETHER WITH all rights and liberties of way and passage for the donee and his servants, occupiers, visitors, invitees, guests and other person or persons authorized the Donee in the said property enjoyed therewith and the enjoyment of the right, privileges, easement, quasi-easement, appendages whatsoever for the use and occupation of the said gifted property TO HAVE AND TO HOLD the said property unto and to the use of the donee, his legal heirs, executors, administrators, legal representatives and assigns absolutely and forever AND THAT the Donee accepted this gift being a party hereto and executing these presents.

THE DONORS HEREBY COVENANTS WITH THE DONEE AND DECLARE AS FOLLOWS :-

- a) The Donors have not in any way transferred, encumbered or made any Agreement with anybody to transfer or encumber his said property hereby transferred by way of gift and that notwithstanding any act, deed, matter or things donee by the Donor or executed or suffered to the contrary, the Donors are absolutely seized and possessed of or otherwise well and sufficiently entitled to an estate equivalent to an absolute estate of inheritance in free simple possession to the said property and every part thereof.
- b) That notwithstanding any act, deeds, matters and things as aforesaid the Donors have good right, full power, absolute authority and indefeasible title to grant, convey, transfer the said property, mentioned in schedule herein below hereby gifted or expressed or intended so to be unto and to the sue of the Donee in the manner aforesaid accordingly to the true intent and meaning of these presents.



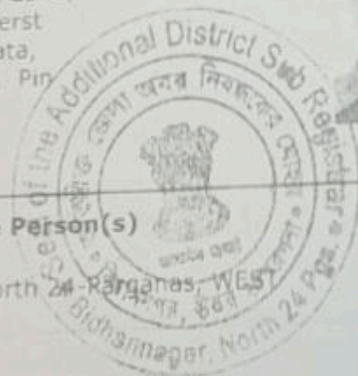
