

- That the time period within which the project shall be completed by 3. promoter is 01/01/2027.
- The seventy per cent of the amounts realised by promoter for the real 4. estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amounts from the separate account, to cover the cost of the 5. project, shall be withdrawn in proportion to the percentage of completion of the project.
