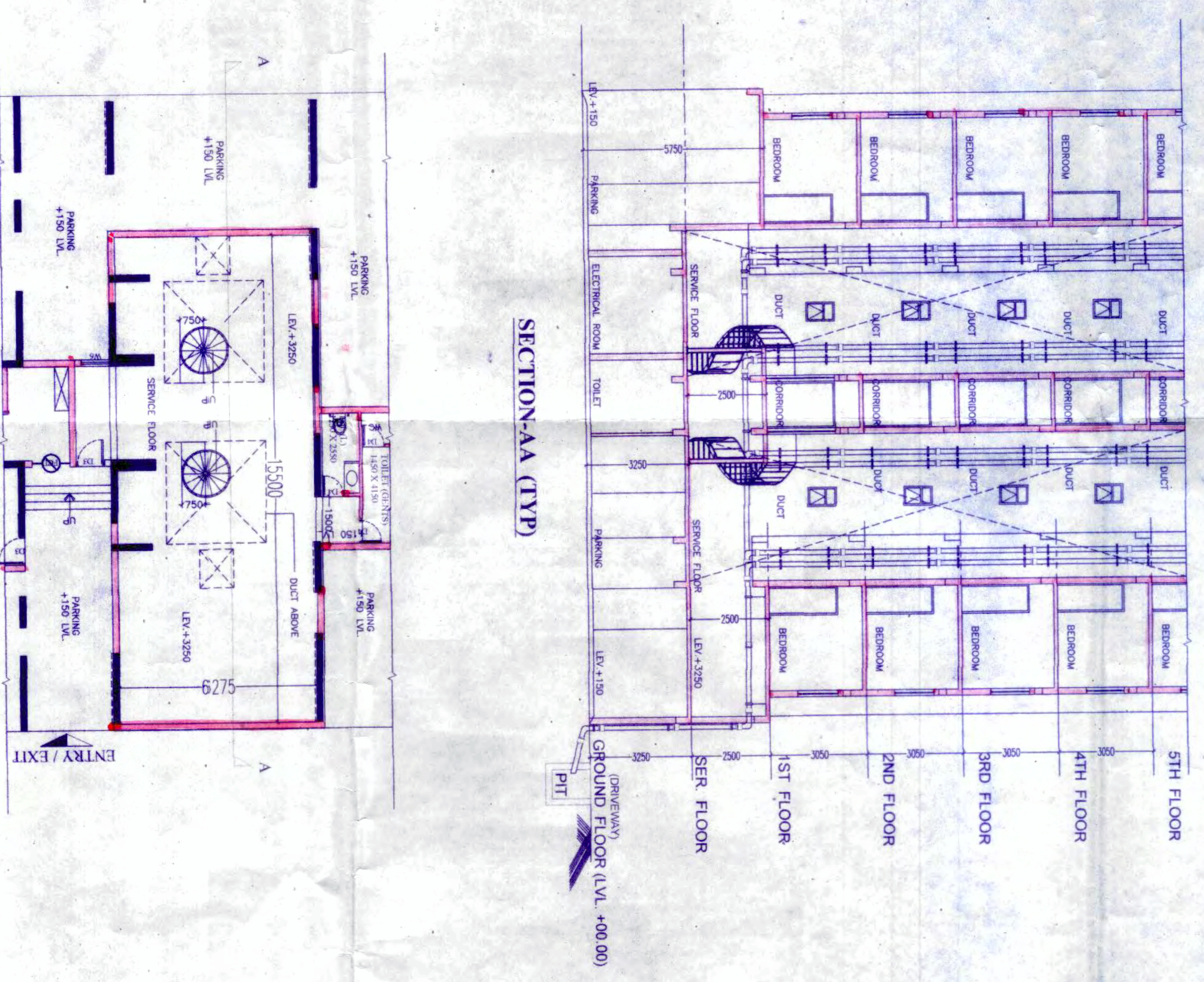


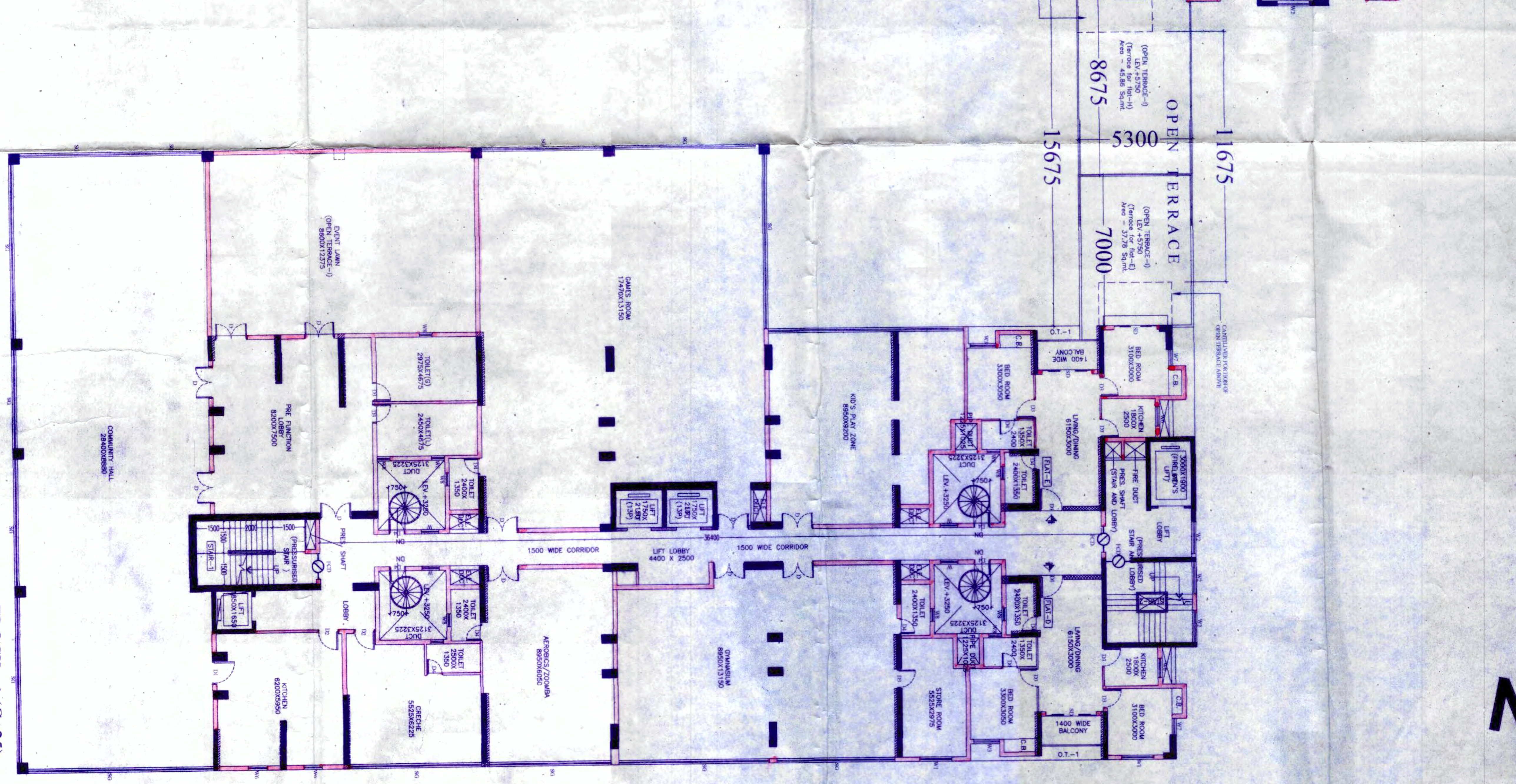


BLOCK - 2 (B-G+24)
