Sri Prakash Kumar, as his only legal heirs and successors as per the provisions of Hindu Succession Act. Accordingly, by virtue of law of inheritance above named 1.Smt. Satyabhama Kanoria, 2. Smt. Kiran Himatsingka, 3. Sri Vinod Kanoria, 4. Sri Bimal Kanoria, 5. Sri Bikash Kanoria and 6. 
NOW THIS INDENTURE WITNESSES AS FOLLOWS:






