WHEREAS one Sri Biswanath Agarwala, son of Late Ramji Lall Agarwala, during his lifetime had purchased land measuring 1 Bighas from Sri Bhairab Prosad Acharjya and Bal Kumar Chettri, by virtue of a registered Deed of Sale, being Document No. I – 2717, Dated 18.09.1959, for the year 1959 and the same was registered in the Office of the Sub-Registrar Siliguri, in the District of Darjeeling.
