5. Background, Representations, Warranties and Covenants

5.1 **Representations and Warranties Regarding Title:** The Vendor has made the following representations and given the following warranties to the Purchasers regarding title:

5.1.3 **Gift by Sandhya Biswas:** By a Deed of Gift in Bengali Language (*Kobala*) dated 24th November, 2006, registered in the Office of Additional District Sub Registrar, Baruipur, in Book No. I, Volume No. 1, at Pages 4254 to 4265, being Deed No. 286 for the year 2009, Sandhya Biswas, out natural love and affection, unconditionally gifted her undivided 1/7th (one seventh) share in the Said Property to her brother, Siddheswar Patra, free from all encumbrances.

5.1.4 **Gift by Pratima Mondal & Ors.:** By a Deed of Gift in Bengali Language (*Kobala*) dated 15th December, 2006, registered in the Office of Additional District Sub Registrar, Baruipur, in Book No. I, Volume No. 1, at Pages 4279 to 4293, being Deed No. 288 for the year 2009, Pratima Mondal, Arati Dalui, Bharati Biswas, Minati Khamaru and Brihaspati Mondal *alias* Runu Mondal jointly, out natural love and affection, unconditionally gifted their undivided 5/7th (five seventh) share in the Said Property to their brother, Siddheswar Patra, free from all encumbrances.

5.1.5 **Ownership of Siddheswar Patra:** By virtue of inheritance and the 2 (two) Deeds of Gift as aforesaid, Siddheswar Patra became the absolute and undisputed owner of the Said Property, free from all encumbrances.

5.1.6 **Purchase by Vendor:** By a Deed of Conveyance dated 21st April, 2011, registered in the Office of District Sub Registrar IV, Alipore, in Book No. I, CD Volume No. 11, at Pages 556 to 569, being Deed No. 3078 for the year 2011, the Vendor purchased the entirety of the Said Property from Siddheswar Patra, free from all encumbrances and for the consideration mentioned therein.

5.1.7 **Absolute Ownership of Vendor:** In the aforesaid circumstances, the Vendor has become the undisputed and absolute owner of the Said Property, free from all encumbrances.

5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendor represents, warrants and covenants regarding encumbrances as follows:

- 5.2.1 **No Acquisition/Requisition:** The Vendor has not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declares that the Said Property is not affected by any scheme of the *Panchayet* Authority or Government or any Statutory Body.


