Dag No. 14 being delineated and demarcated on the Plan annexed hereto and bordered in colour Red thereon (Said Property), together with all title, benefits, easements, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendor in the Said Property and appurtenances and inheritances for access and user thereof.
- 5. Background, Representations, Warranties and Covenants


