And after purchasing the land as mentioned above the above named Vendor No.1 has duly mutated and recorded his name in respect of the said land at the office of the B.L. & L.R.O. Matigara at Shivmandir and accordingly a new L.R. Khatian being No.1966 has been opened in his name by

the said authority. Dist. Sub-Registrar, Siliguri-II at Bagdogra. And moreover after purchasing the land as mentioned above the above named Vendor No.2 has duly mutated and recorded his name in respect of the said land at the office of the B.L. & L.R.O. Matigara at Shivmandir and accordingly a new L.R. Khatian being No.1905 has been opened in his name by the said authority.

Bharati Jaiswal (since deceased) became the absolute coowners in khas, actual and physical possession of all that 8.37 Kathas or about 0.1381 Acre of land appertaining to and forming part of L.R. Plot Nos.190 & 194 corresponding to R.S. Plot Nos.68 & 71, recorded in the then Khatian No.448 (New) & 27 (old), within Mouza Baragharia, J.L. No.82, under P.S. Matigara, Dist. Darjeeling, by virtue of purchase for valuable consideration from Shelcon Properties (P) Ltd., a private limited company having its registered office at Hill Cart Road, Siliguri, through a Deed of Conveyance being document No.I-682 for the year 2015 registered at the office of the Addl. Dist. Sub-Registrar, Siliguri-II at Bagdogra. And moreover after purchasing the land as mentioned above the above named Sri Prahlad Jaiswal and his said wife have/had duly mutated and recorded their names in respect of the said land at the office of the B.L. & L.R.O. Matigara at Shivmandir and accordingly two new separate L.R. Khatian being No.1821 & 1822 have been opened in their respective names by the said authority.

AND WHEREAS subsequently on 10.03.2019 above named Bharati Jaiswal, W/o Sri Prahlad Jaiswal, died intestate leaving behind her husband i.e. said Sri Prahlad Jaiswal and her two minor sons namely Master Priyanshu Jaiswal and Master Anish Jaiswal as her sole legal heirs and successors who accordingly jointly inherited the undivided 50% share in said 8.37 Kathas or about 0.1381 Acre of land which is measuring about 4.185 Kathas or 0.06905 Acre, as per the provisions of the Hindu Succession Act, 1956. It is pertinent to mention here that Sri Prahlad Jaiswal had been appointed as the Guardian of the person and property of said two minor sons namely Master Priyanshu Jaiswal and Master Anish Jaiswal by the Court of the Ld. District Judge, Darjeeling in reference to Act VIII Case No.10/2019 vide order dated 11.11.2019 within the purview of U/Sec 10 of Guardian and Wards Act, 1890.

(VI) AND WHEREAS subsequently being the natural guardian of said Master Priyanshu Jaiswal and Master Anish Jaiswal, the Vendor No.5 hereof (i.e. Sri Prahlad Jaiswal) as well as by dint of above referred Court order, above named Sri Prahlad Jaiswal finally sold and transferred all that entire  $2/3^{\rm rd}$  undivided share of said Master Priyanshu Jaiswal and Master Anish Jaiswal in the said 4.185 Kathas or 0.06905 Acre of land which is measuring about 2.79 Kathas or 0.046 Acre of land unto and in favour of M/S. DARJEELING REAL ESTATE AGENTS & DEVELOPERS (i.e. the Vendor No.7 hereof) through a Deed of Conveyance being document No. I - 1204 for the year 2020 registered at the office

of the A.D.S.R. Siliguri, at Bagdogra. And after purchasing the said land above named M/S. DARJEELING REAL ESTATE AGENTS & DEVELOPERS (i.e. the Vendor No.7 hereof) has also duly mutated and recorded its name in respect of the said land at the office of the B.L. & L.R.O. Matigara at Shivmandir and accordingly a new L.R. Khatian being No.3179 has been opened in its name by the said authority.

AND WHEREAS it is mentioned here that thereafter the Vendor No.5 hereof (i.e. Sri Prahlad Jaiswal) remained in khas possession of all that remaining 5.58 Kathas or 0.0921 Acre of land as recorded in L.R. Khatian Nos.1821 & 3210, having with permanent, heritable and transferable right, title and interest there in free from all encumbrances and charges whatsoever.

(VII)AND WHEREAS the Vendor No.6 i.e. RUKSHANA BEGUM, Wife of Md. Jahur, as named herein above became the absolute owner in possession of all that 5 Kathas of land appertaining to and forming part of L.R. Plot No.190 corresponding to R.S. Plot No.68, recorded in KhatianNo.448 (New) & 27 (old), within Mouza Baragharia, J.L. No.82, under P.S. Matigara, Dist. Darjeeling by virtue of purchase for valuable consideration from Shelcon Properties (P) Ltd., a private limited company having its registered office at Hill Cart Road, Siliguri, through a Deed of Conveyance being document No.I-661 for the year 2015 registered at the office of the Addl. Dist. Sub-Registrar, Siliguri-II at Bagdogra. And moreover after purchasing the land as mentioned above the above named Vendor No.6 has duly mutated and recorded her name in respect of the said land at the office of the B.L. & L.R.O. Matigara at Shivmandir and accordingly a new L.R. Khatian being No.1968 has been opened in her name by the said authority.

AND WHEREAS in the aforesaid manner the Vendors hereto referred above have become the absolute co-owners in respect of all that piece or parcel of altogether land measuring 42.22 Kathas out of which land measuring 23.35Kathas appertaining to and forming part of R.S. Plot No.68, L.R. Plot No.190, and land measuring 18.87Kathas appertaining to and forming part of R.S. Plot No.71, L.R. Plot No.194, recorded in L.R. Khatian Nos. 1966, 1905, 1967, 1934, 1821, 3210, 3179 & 1968, in Mouza Baragharia, J.L. No.82, Sheet No.1, within the jurisdiction of P.S. Matigara, Pargana Patharghata, Dist. Darjeeling as fully described in Schedule –A below free from all encumbrances and charges whatsoever.

AND WHEREAS being the absolute co-owners of the afore mentioned land the parties of the First Part on 30.09.2020 jointly signed and affirmed an affidavit before the Ld. Executive Magistrate, at Siliguri for amalgamation of their above mentioned entire 42.22 Kathas of land and thereafter the Vendor No.1 to 6 hereof have entered into development agreement with the Promoter/Developer hereof with intent to raise multi storey residential cum commercial complex

there upon the said land vide document No. I- 05501 for the year 2020 registered at the office of the A.D.S.R. Siliguri-II at Bagdogra and in furtherance of the said development agreements the Promoter/Developer has also initiated development works upon the below scheduled land.

AND WHEREAS meanwhile the Vendors/Promoter have obtained a duly sanctioned building plan to construct a commercial cum residential complex (B + 4 storied building/s) on the Schedule-"A" land being building plan vide Order No. 426 dated 20/04/2022 approved by Matigara Panchayat Samity. And in the process the Vendors/Promoter have also obtained "LAND USE CERTIFICATE (LUC)"issued by the office of the Siliguri Jalpaiguri Development Authority, vide its Memo No. 5511/SJDA dated 17.03.2021 and Fire Safety Certificate issued by Deputy Director, West Bengal Fire and Emergency Services, vide Memo No. FSR/0125186210500136,dated 02.08.2021.

The said Land is earmarked for the purpose of a Basement plus Four Storied Residential Cum Commercial building and the said project shall be known as "PANCHNAI SHREEDHAM".

- **B.** The Vendors/Promoter are fully competent to enter into this Agreement and all the legal formalities with respect to the right, title and interest of the Vendors regarding the said land on which Project is to be constructed have been completed;
- **C.** The Matigara Panchayat Samity has granted the commencement certificate to construct the Project vide approved plan, bearing Plan No.426/MPS/Planning, Dated 20.04.2022.
- **D.** The Vendors/Promoter have obtained the final layout plan approvals for the Project from Matigara Panchayat Samity. The Vendors/Promoter agree and undertake that it shall not make any changes to these layout plans except in strict compliance with section 14 of the Act and other laws as applicable;
- **E.** The Vendor shall register the Project under the provisions of the Act with the Real Estate Regulatory Authority as and when the said Authority commences its operations in the State of West Bengal.

- **G.** The Parties have gone through all the terms and conditions set out in this Agreement and understood the mutual rights and obligations detailed herein;
- **H.**The Parties hereby confirm that they are signing this Agreement with full knowledge of all the laws, rules, regulations, notifications, etc, applicable to the Project;
- I. The Parties, relying on the confirmations, representations and assurances of each other to faithfully abide by all the terms, conditions and stipulations contained in this Agreement and all applicable laws, are now willing to enter into this Agreement on the terms and conditions appearing herein after.
- **J.** In accordance with the terms and conditions set out in this Agreement and as mutually agreed upon by and between the Parties, the Vendors/Promoter hereby agree to sell and the Allottees here by agree to purchase the Schedule 'B' Property.

NOW THEREFORE, in consideration of the mutual representations, covenants, assurances, promises and agreements contained herein and other good and valuable consideration, the Parties agree as follows:

# TERMS:

Subject to the terms and conditions as detailed in this Agreement, the Vendor agrees to sell to the Allottee(s) and the Allottee(s) hereby agrees to purchase, the Apartment as specified in paragraph F;

#### Explanation:

The Total Price above includes the booking amount paid by the Allottee(s) to the Vendor/Promoter towards the Apartment:

The Total Price above excludes Taxes (consisting of tax paid or payable by the Vendor, if any as per law, and Cess or any other taxes which may be levied, in connection with the construction of the Project) up to the date of handover the possession of the Apartment:

Provided that in case there is any change/ modification in the taxes, the subsequent amount payable by the Allotter(s) to the Vendors/Promoter shall be increased/reduced based on such changes/modification;

The Vendors/Promoter shall periodically intimate to the Allottee(s), the amount payable as stated in (1.1) above and the Allottee(s) shall

make payment within 30 (thirty) days from the date of such written intimation. In addition, the Vendors/Promoter shall provide to the Allottee(s) the details of the taxes paid or demanded along with the acts/rules/notifications together with dates from which such taxes/levies etc. have been imposed or become effective;

The Total price of Apartment includes: 1) proportionate share in the Common Areas; and 2) Flat & parking(s) as provided in this Agreement.

The Total price is escalation- free, save and except increases which the Allottee(s) hereby agrees to pay, due to increase on account of development charges payable to the competent authority and/or any other increase in charges which may be levied or imposed by the competent authority from time to time. The Vendors/Promoter undertake and agree that while raising a demand on the Allottee(s) for increase in development charges, cost charges imposed by the competent authorities, the Vendors/Promoter shall enclose the said notification/order/rule/regulation to that effectalongwiththedemandletterissuedtotheAllottee(s), which shall only be applicable on subsequent payments.

The Allottee(s) shall make the payment as per the payment plan set out in Schedule C ("Payment plan").

It is agreed that the Vendors/Promoter shall not make any additions and alterations in the sanctioned plans, layout plans and specifications and the nature of fixtures, fittings and amenities described therein in respect of the apartment, plot or building, as the case maybe, without the previous written consent of the Allottee(s). Provided that the Vendors/Promoter may make such minor additions or alterations as may be required by the Allottee(s), or such minor changes or alterations as per the provisions of the Act.

Subject to Clause 9.3 the Vendors/Promoter agrees and acknowledges, the Allottee(s) shall have the right to the [Apartment] as mentioned below:

The Allottee(s) shall have exclusive ownership of the [Apartment]. The Allottee(s) shall also have undivided proportionate share in the Common Areas. Since the share / interest of Allottee(s) in the Common Areas is undivided and cannot be divided or separated, the Allottee(s) shall use the Common Areas along with other occupants, maintenance staff etc., without causing any inconvenience or hindrance to them. Further, the right of the Allottee(s) to use the Common Areas shall always be subject to the timely payment of maintenance charges and other charges as applicable. It is clarified that the Vendors/Promoter

shall convey undivided proportionate title in the common areas to the association of Allottee(s) as provided in the Act;

That the computation of the price of the [Apartment] includes recovery of price of land, construction of [not only the apartment but also] the common areas, internal development charges, external development charges, taxes, cost of providing electric wiring, fire detection and firefighting equipment in the common areas etc. and includes cost for providing all other facilities as provided within the Project.

It is made clear by the Vendors/Promoter and Allottee(s) agrees that the [Apartment] along with parking shall be treated as a single indivisible unit for all purposes. It is agreed that the Project is an independent, self- contained Project covering the said Land and is not a part of any other projector zone and shall not form a part of and/ or linked / combined with any other project in its vicinity or otherwise except for the purpose of integration of infrastructure for the benefit of the Allottee(s). It is clarified that Project's facilities and amenities shall be available only for use and enjoyment of the Allottee(s) of the Project.

The Vendors/Promoter agrees to pay all outgoings before transferring the physical possession of the apartment to the Allottee(s), which it has collected from the Allottee(s), for the payment of outgoings (including land cost, ground rent, municipal or the other local taxes, charges for water or electricity, maintenance charges, including loan mortgage and interest mortgages otherencumbrancesandsuchotherliabilitiespayabletocompetentauthori ties, banks and financial institutions, which are related to project). If the Vendors/Promoter fail to pay all or any of the outgoings collected by it from the Allottee(s) or any liability, mortgage loan and interest thereon before transferring the apartment to the Allottees, the Vendors/Promoter agree to be liable, even after the transfer of the property, to pay such outgoings and penal charges, if any, to the authority or person to whom they are payable and be liable for the cost of any legal proceedings which may be taken therefore by such authority or person.

The Allottee(s) has paid a sum of Rs\_\_\_\_\_\_/-(Rupees\_\_\_\_\_Only) by Cheque/RTGS/Demand Draft, inclusive of G.S.T. as booking amount being part payment towards the Total Price of the [Apartment] at the time of Application the receipt of which the Vendors/Promoter hereby acknowledge and the Allottee(s) hereby agrees to pay the remaining price of the [Apartment] as prescribed in the Payment Plan as may be demanded by the Vendors/Promoter within the time and manner specified therein:

Provided that if the Allottee(s) delay in payment towards any amount for which is payable, he shall be liable to pay interest at the rates specified in the Rules.

#### 2. MODE OF PAYMENT

That if the Allottee(s) delays in payment to the Vendors/Promoter then the interest will be payable by the purchaser at the rate of 12% p.a. from the date on which the installment falls due till the date of actual payment.

#### 3. COMPLIANCE OF LAWS RELATING TO REMITTANCES

The Allottee(s), if resident outside India, shall be solely responsible for complying with the necessary formalities as laid down in Foreign Exchange Management Act, 1999, Reserve Bank of India Act and Rules and Regulations made there under or any statutory amendment(s) modification(s) made thereof and all other applicable laws including that of remittance of payment acquisition/sale/transfer immovable properties in India etc. and Vendors/Promoter with such permission, approvals which would enable the Vendors/Promoter to fulfill its obligations under this Agreement. Any refund, transfer of security, if provided in terms of the Agreement shall be made in accordance with the provisions of Foreign Exchange Management Act, 1999 or statutory enactments or amendments thereof and the Rules and Regulations of the Reserve Bank of India or any other applicable law. The Allottee(s) understands and agrees that in the event of any failure on his/her part to comply with the applicable guidelines issued by the Reserve Bank of India; he/she shall be liable for any action under the Foreign Exchange Management Act, 1999orotherlaws as applicable, as amended from time to time.

The Vendors/Promoter accepts no responsibility in this regard. The Allottee(s) shall keep the Vendors/Promoter fully indemnified and harmless in this regard. Whenever there is any change in the residential status of the Allottee(s) subsequent to the signing of this Agreement, it shall be the sole responsibility of the Allottee(s) to intimate the same in writing to the Vendors/Promoter immediately

and comply with necessary formalities if any under the applicable laws. The Vendors/Promoter shall not be responsible towards any Third party making payment/ remittances on behalf of any Allottee(s) and such third party shall not have any right in the application/ allotment of the said apartment applied for here in in anyway and the Vendors/Promoter shall be issuing the payment receipts in favour of the Allottee(s) only.

#### 4. ADJUSTMENT/APPROPRIATIONOFPAYMENTS

The Allottee(s) authorizes the Vendors/Promoter adjust/ appropriate all payments made by him/her under any head(s) of dues against lawful outstanding, if any, in his/ her name as the Vendors/Promoter may in its sole discretion deem fit and the Allottee(s) undertakes not to object/ demand/ direct the Vendors/Promoter to adjust his payments in any manner.

#### 5. TIMEISESSENCE

Time is of essence for the Vendors/Promoter as well as the Allottee(s). The Vendors/Promoter shall abide by the time schedule for completing the project and handing over the Apartment to the Allottee(s) and the common areas to the association of the Allottees. Similarly, the Allottee(s) shall make timely payments of the installment and other dues payable by him/ her and meeting the other obligations under the Agreement subject to the simultaneous completion of construction by the Vendors/Promoter as provided in Schedule C("Payment Plan")

# 6. CONSTRUCTION OF THE PROJECT/APARTMENT

The Allottee(s) has seen the specifications of the [Apartment] and accepted the Payment Plan, floor plans, layout plan which has been approved by the competent authority, as represented by the Vendors/Promoter. The Vendors/Promoter shall develop the Project in accordance with the said layout plans, floor plans and specifications. After refund of the money paid by the Allottee(s), Allottee(s) agrees that he/she shall not have any rights, claims etc. against the Vendors/Promoter and that the Vendors/Promoter shall be released and discharged from all its obligations and liabilities under this Agreement.

Provided that where if the Allottee(s) does not intend to withdraw from the Project, the Vendors/Promoter shall pay the Allottee(s) interest at the rate specified in the Rules for every month of delay, till the handing over of the possession of the Apartment.

#### 8. REPRESENTATIONS AND WARRANTIES OF THE VENDOR

- 8.4 There are no litigations pending before any Court of law with respect to the said Land, Project or the [Apartment];
- 8.5 All approvals, licenses and permits issued by the competent authorities with respect to the Project, said Land and [Apartment] are valid and subsisting and have been obtained by following due process of law. Further, the Vendors/Promoter have been and shall, at all

times, remain to be incompliance with all applicable laws in relation to the Project, said Land, Building and [Apartment] and common areas;

- 8.6 The Vendors/Promoter have the right to enter into this Agreement and have not committed or omitted to perform any actor thing, where by the right, title and interest of the Allottee(s) created herein, may prejudicially be affected;
- 8.7 The Vendors/Promoter have not entered in to any agreement for sale and/ or development agreement or any other agreement arrangement with any person or party with respect to the said Land, including the Project and the said [Apartment) which will, in any manner, affect the rights of Allottee(s) under this Agreement;
- 8.8 The Vendors/Promoter confirm that the Vendors/Promoter is/are not restricted in any manner whatsoever from selling the said (Apartment) to the Allottee(s) in the manner contemplated in this Agreement;
- 8.9 At the time of execution of the conveyance deed the Vendors/Promoter shall handover lawful, vacant, peaceful, physical possession of the [Apartment) to the Allottee(s) and the common areas to the Association of the Allottees.
- 8.10 The Schedule Property is not the subject matter of any HUF and that no part thereof is owned by any minor and / or no minor has any right, title and claim over the Schedule Property:
- **8:11** The Vendors/Promoter have duly paid and shall continue to pay and discharge all governmental dues, rates, charges and taxes and other monies, levies, impositions, premiums, damages and/ or penalties and other out goings, what so ever, payable with respect to the said project to the competent Authorities;
- **8.12** No notice from the Government or any other local body or authority or any legislative enactment, government ordinance, order, notification (including any notice for acquisition or requisition of the said property) has been received by or served upon the Vendors/Promoter in respect to of the said Land and/or the Project;
- **8.13**. That the Vendors/Promoter shall provide Electric Transformer in the Complex and the Allottee(s) Purchaser shall obtain his individual Electric connection by depositing the required Security Deposit.
- **8.14** That the property is not Wagf property.
- 9. EVENTS OF DEFAULT SAND CONSEQUENCES
  Subject to the Force Majoure along the Vendors/Pr

Subject to the Force Majeure clause, the Vendors/Promoter shall be considered under a condition of Default, in the following events

Vendors/Promoter fail to provide ready to move in possession of the [Apartment) to the Allottee(s) within the time period specified. For the purpose of this clause, 'ready to move in possession shall mean that the apartment shall be inhabitable condition which is complete in all respects;

Discontinuance of the Vendors/Promoter business on account of suspension or revocation of his registration under the provisions of the Actor the rules or regulations made there under.

In case of Default by Vendors/Promoter under the conditions listed above, Allottee(s) is entitled to the following:

- (i) Stop making further payments to Vendors/Promoter as demanded by the Vendors/Promoter. The Vendors/Promoter shall be responsible to provide and maintain essential services in the Project till the taking over of the maintenance of the project by the association of the Allottees. The cost of such maintenance has been included in the Total Price of the [Apartment).

# 12. DEFECT LIABILITY

The Vendors/Promoter maintenance agency/association of Allottees shall have rights of unrestricted access of all Common Areas, parking's and parking spaces Re providing necessary maintenance services and the All) as to permit the association of Allottees and or maintenance agency to enter into the Apartment) or any part thereof, after due motive and during the normal working hours, unless the circumstances want otherwise, with a view to set right any deflect.

#### 15 USAGE

Use of Parking and Service Areas: The Parking(s) and service areas, if any, as located within the "PANCHNAI SHREEDHAM", shall be earmarked for purposes such as parking spaces and services including but not limbed to electric sub-station, transformer, DG set rooms, underground water tanks, pump rooms, maintenance and service rooms, fire-fighting pumps and equipment's etc. and other permitted uses as per sanctioned plant. The Allottee(s) shall not be permitted to use the services areas and the basements in any manner whatsoever, other than those earmarked as parking spaces, and the same shall be reserved for use by the association of Allottee(s) shall fix the outdoor unit of Air Conditioners in the area specifically marked by the Vendors/Promoter.

#### 16 GENERAL COMPLIANCE WITH RESPECT TO THE APARTMENT:

Subject to Clause 12 above, the Allottee(s) shall, after taking possession, be solely responsible to maintain the [Apartment] at his/her own cost, in good repair and condition of the Building, or the Apartment, or the staircases, lift, common passages, corridors, circulation areas, atrium or the compound which may be in violation of any laws or rules of any authority or change or alter or make additions to the Apartment and keep the [Apartment], its walls and partitions, sewers, drains, pipe and appurtenances thereto or belonging thereto, in good and tenantable repair and maintain the same in a fit and proper condition and ensure that the support, shelter etc. of the Building is not in any way damaged or jeopardized. The Allottee(s) further undertakes, assures and guarantees that he/ she would not put sign-board/name-plate, neon light, publicity advertisement material etc. on the face / facade of the Building or anywhere on the exterior of the Project, buildings therein or Common Areas. The Allottee(s) shall also not change the colour scheme of the outer walls or painting of the exterior side of the windows or carry out any change in the exterior elevation or design. #### 18. ADDITIONAL CONSTRUCTIONS

The Vendors/Promoter undertake that it has no right to make additions or to put up additional structure(s) anywhere in the Project after the building plan has been approved by the competent authority(ies) except for as provided in the Act.

# 19. VENDORS/PROMOTER SHALL NOT MORTGAGE OR CREATE CHARGE

After the Vendors/Promoter execute this Agreement he shall not mortgage or create a charge on the [Apartment] and if any such mortgage or charge is made or created then not withstanding anything contained in any other law for the time being in force, such mortgage or charge shall not affect the right and interest of the Allottee(s) who has taken or agreed to take such Apartment.

# 20. APARTMENT OWNERSHIP ACT

The Vendors/Promoter have assured the Allottees that the project in its entirety is in accordance with the provisions of the West Bengal Apartment Ownership Act, 1972. The Vendors/Promoter showing compliance of various laws/ regulations as applicable in the State of West Bengal.

#### 21. BINDINGEFFECT

Forwarding this Agreement to the Allottee(s) by the Vendors/Promoter does not create a binding obligation on the part of the Vendors/Promoter or the Allottee(s) until, the Allottee(s) signs and delivers this Agreement with all the schedules along with the payments due as stipulated in the Payment Plan within 30(thirty) days from the date of receipt by the Allottee(s)

#### 22. ENTIRE AGREEMENT

This Agreement, along with its schedules, constitutes the entire Agreement between the Parties with respect to the subject matter hereof and supersedes any and all understandings, any other agreements, allotment letter, correspondences, arrangements whether written or oral, if any, between the Parties in regard to the said apartment/plot/ building, as the case may be.

#### 23. RIGHT TO AMEND

This Agreement may only be amended through written consent of the Parties.

# **24.** PROVISIONS OF THIS AGREEMENT APPLICABLE ON ALLOTTEE(S)/ SUBSEQUENT ALLOTTEE(S)

It is clearly understood and so agreed by and between the Parties here to that all the provisions contained herein and the obligations arising here under in respect of the Project shall equally be applicable to and enforceable against any subsequent Allottees of the [Apartment], in case of a transfer, as the said obligations go along with the [Apartment] for all intents and purposes.

#### 25. WAIVER NOT ALIMITATION TO ENFORCE

It is made clear and so agreed by the Allottee(s) that exercise of discretion by the Vendors/Promoter in the case of one Allottee(s) shall not be construed to be a precedent and/ or binding on the Vendors/Promoter to exercise such discretion in the case of other Allottees.

Failure on the part of the Vendors/Promoter to enforce at any time or for any period of time the provisions hereof shall not be construed to be a waiver of any provisions or of the right there after to enforce each and every provision.

#### 26. SEVERABILITY

If any provision of this Agreement shall be determined to be void or unenforceable under the Actor the Rules and Regulations made there under or under other applicable laws, such provisions of the Agreement shall be deemed amended or deleted in so far as reasonably inconsistent with the purpose of this Agreement and to the extent necessary to conform to Act or the Rules and Regulations made there under or the applicable law, as the case maybe, and the remaining provisions of this Agreement shall remain valid and enforceable as applicable at the time of execution of this Agreement.

# **27.** METHOD OF CALCULATION OF PROPORTIONATE SHARE WHEREVER REFERRED TO IN THE AGREEMENT
