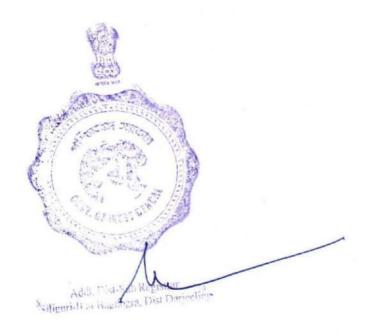

WHEREAS one Sri Prahlad Jaiswal, Son of Late Rambharat Jaiswal and his wife namely Smt.
