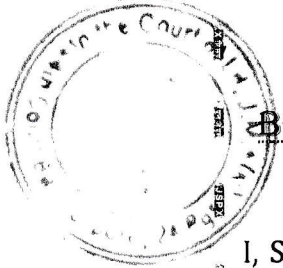

AFFIDAVIT

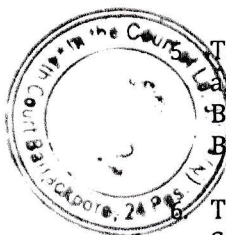

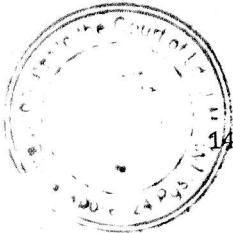

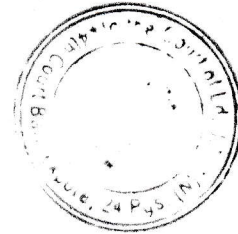
