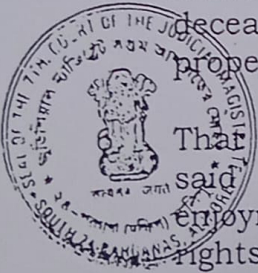
AFFIDAVIT

2. That Gurudas Basu, since deceased was the sole and absolute owner and possessor of **ALL THAT** piece and parcel of 04 decimals of land at R.S. Dag No. 153, L.R. Dag No. 232 and 15 decimals of land in R.S. Dag No. 149, L.R. Dag No. 228, L.R. Khatian No. 340, Mouza-Muradpur, P.S.-Behala, J.L. No. 13, Block- Thakurpukur-Metiabruz, District - South 24 Parganas was originally owned and possessed by Gurudas Basu son of Rashbehari and his name was correctly recorded in the Record of Rights.
