And whereas said Lailee Saha for self and on behalf of Vikram Saha and Monali Das sold, transferred and conveyed a part of land measuring about 23 Cottahs together with structure standing thereon unto and in favour of M/s Aatreyee Nirman Pvt. Ltd. by way of a Sale Deed dated 17.07.2013 and the same was duly registered with the office of the Additional District Sub Registrar of Cossipore Dum Dum and recorded in Book no.I, CD Volume no.17, Pages 8035 to 8051, Being no.7039 for the year 2013.

And whereas said Lailee Saha for self and on behalf of Vikram Saha and Monali Das sold, transferred and conveyed rest part of land measuring about 6 Cottahs 28.8 Sq. ft. together with structure standing thereon unto and in favour of M/s Aatreyee Nirman Pvt. Ltd. by way of a Sale Deed dated 17.07.2013 and the same was duly registered with the office of the Additional District Sub Registrar of Cossipore Dum Dum and recorded in Book no.I, CD Volume no.18, Pages 4085 to 4100, Being no.7036 for the year 2013.

And whereas aforesaid two plots of land amalgamated into a single plot measuring about 1 Bigha 9 Cottahs 28.8 Sq. ft. and accordingly said M/s Aatreyee Nirman Pvt. Ltd. becomes the absolute owner of all that piece and parcel of land measuring about 1 Bigha 9 Cottahs 28.8 Sq. ft. together with structure standing thereon.
