- 4) No Vehicle will be allowed parking on the road and will be always free for passersby.
- 5) The petitioners should obtain all other approvals from respective department as applicable for this proposed building as per current laws in force. The board is not responsible for those approvals and non receipt of those the plan will be treated as cancel.
- 6) The construction should be done after maintaining all the rules and regulation specified under B.M.Act, otherwise the plan may be treated as cancel.
- 7) The petitioners should construct an arrangement for drinking water facility within their own holding for the dwellers of this building.
- 8) All electrical arrangement of this building like pole, transformer ect. Must be installed within the holding owners own land after keeping necessary distance from other holdings as per rule of WBSEDCL.
- 9) The petitioners should construct/install a rain water harvesting system inside his compound.
- 10) The construction should be done under the supervision of a technical expert qualified in Civil Engineering. The board is not responsible for any type of structural defect/problem.
- 11) If any legal dispute arises regarding the title of properties or part there of or from nearest holding owner the plan will be treated as cancelled & no way this board will be liable for that.
