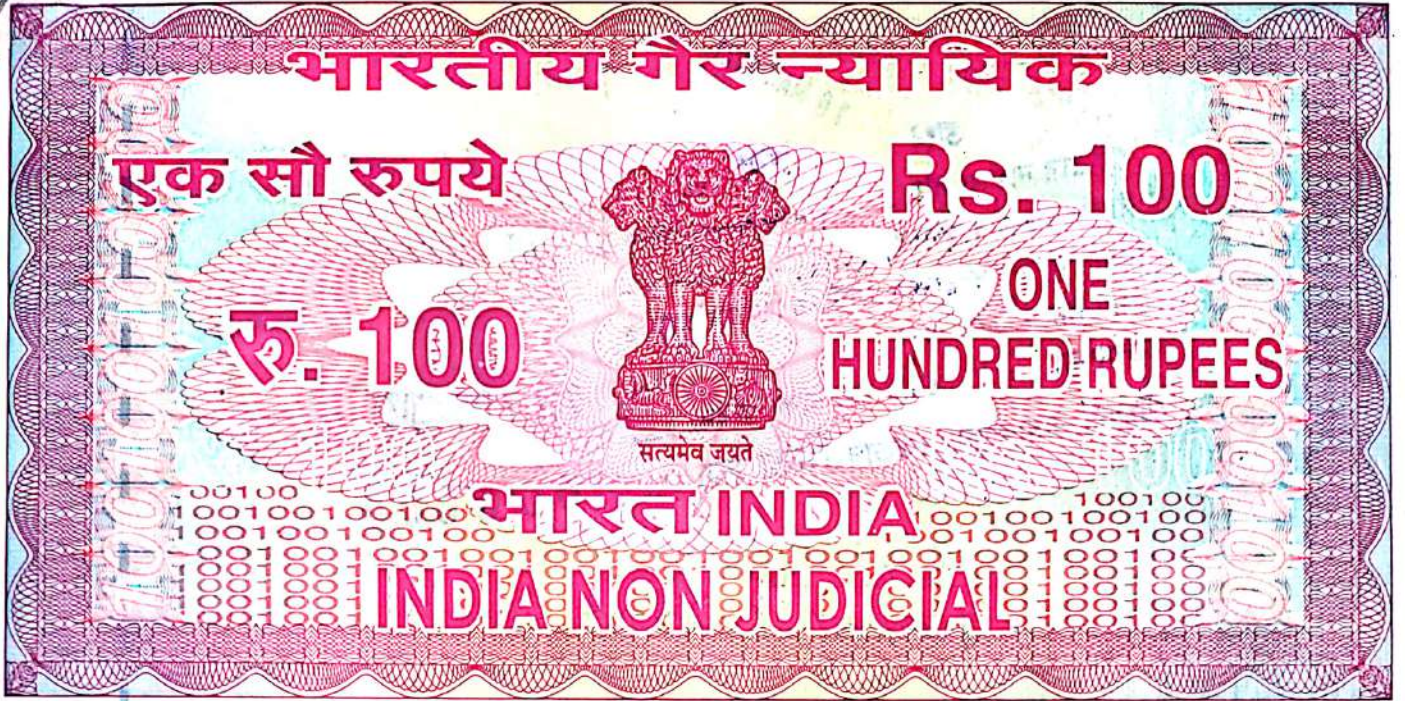

The **FIRST PARTY, SECOND PARTY, THRID PARTY AND FOURTH PARTIES** herein collectively are collectively called the **PARTIES** and which shall mean and include their heirs, executors, administrators, legal representatives.

WHEREAS the parties herein are well known to each other. That all the Parties herein have jointly decided to start a partnership business of building construction, supply of all kind of building construction materials under the name and style of "**THE BENGAL WINGS**" having its principal place of business at **9A, Circus Market Place, P.O-Circus Avenue, P.S-Karaya, Kolkata-700017** and site office at **Salua Gopalpur, P.S-Airport, P.O-Rajarhat Gopalpur, Dist-North 24 Parganas, Kolkata-700136** under the terms and conditions as settled in between them and hereunder written.

AND WHEREAS the parties now have agreed between themselves to have their function more fully recorded and described in the **DEED OF PARTNERSHIP** to safeguard their respective right, title and interest in the partnership business against any future dispute and/or this agreement among themselves and their heirs/representative while during the continuance of the partnership or at the termination in relation to any matter whatsoever touching the said partnership affairs.

NOW THIS INDENTRUE WITNESSETH this in pursuance to this agreement aforesaid the above named parties do hereby agree and undertake to carry on the said business under the terms and conditions enumerated below :-

NAME AND STYLE OF THE FIRM:

1. The partnership business shall be carried on under the name and style of "THE BENGAL WINGS" and the purpose of the partnership business mainly shall be real estate, development of house building and supply of all kind of building construction materials.

REGISTERED OFFICE :

2. The Partnership business shall be carried on from its principle office situated at present at **9A, Circus Market Place, P.O-Circus Avenue, P.S-Karaya, Kolkata-700017** or such other place or places including **Salua Gopalpur, P.S-Airport, P.O-Rajarhat Gopalpur, Dist-North 24 Parganas, Kolkata-700136**, as the parties may mutually agree in writing.

OBJECT :

3. That the business of the partnership shall be mainly for real estate, development and/or construction of house building and supply of all kind of building materials and any other business which the partners herein will mutually decide to do and/or may think fit.

COMMENCEMENT AND DURATION OF BUSINESS:

4. The commencement of this partnership business in on and from **31ST Day of January , 2021** and the partnership business shall continue till determined by the mutual consent of the partners or as provided in the DEED.

CAPITAL :

5.A) The capital of the business shall be Rs.40,000/- (Rupees Forty Thousand) only to be brought into the said business by **all** the partners equally and the same shall carry interest at the rate of 12% per annum which shall be cumulative and paid out of book of profits except when the firm suffered any loss and in that case the loss will be carried over and set off against the profit of the subsequent year or years. The share in contribution over the capital, profit and loss of the business in between the partners shall be in equal ratio.

- 5.B) That in case any further capital will be required in the partnership business in future the same shall be contributed by the partners if they so like or the partnership will be at liberty to borrow such sum on person on such terms and conditions as may be agreed upon among the parties from time to time in writing.

LOAN FROM PARTNERS :

6. Any amount over above the Capital written which may be brought in or arranged by any partner shall be taken as loan to the firm with the consent of other partners and the ratio of interest on same shall be determined as the market rate or the Bank rate of the time which the Loan has been taken but in case of waiver of interest on such loan such power of waiver shall be possessed by that partner or partners who will provide loan to the Firm.

PROFIT AND LOSS SHARING :

7. The profit and/or Losses of the firm determined in accordance with the provisions contained herein shall be shared by the partners in the following ratio:-

FIRST PARTY	--	25%
SECOND PARTY	--	25%
THIRD PARTY	--	25%
FOURTH PARTY	--	25%

BANK ACCOUNT :

8. The firm shall maintain one or more Banking account with Bank or Banks, as may be decided upon by the partners for the time being of the firm. The bankers of the partnership shall be such other bankers as the partners shall agree upon; and all moneys belonging to partnership not required for current expenses, shall be paid into the bank to the credit of the partnership account, and the all cheques shall be withdrawn in the name of the firm.

9. REMUNERATION :

- a) That all four partners are working partners and shall be entitled to draw their remuneration on monthly basis as may be mutually agreed upon, which shall continue to be so paid unless otherwise mutually agreed upon by and between them.
- b) Each partner shall be paid remuneration accordance with the limits stated in the Section 40(b) of the Income Tax Act in their profit – sharing ratio. The remuneration paid in excess would be deemed to be the drawings of the respective partners.

10. ACCOUNTS :

- a) The proper books of accounts shall be kept by the partners herein and shall be entered particulars of all matters relating to the said partnership business as are usually entered in the books of accounts kept by the person engaged in the same line of business and the consolidated profit and loss account of each year shall be entered in the account books maintained for the purpose. The said books of accounts with all securities, if any, documents, letters, or other things concerning or belonging to the partnership shall be kept in the office of the firm and shall not be removed without the consent in writing of other partner. Both the partners shall have full access to the books at times and shall be at liberty to check them up and take copies.
- b) A general account and valuation shall be taken once every year on 31st day of March (Accounting year shall be from 1st day of April to 31st March) unless otherwise agreed upon exceptional circumstances, of profit and losses of the business carried on by the firm and a Balance Sheet prepared of the firm assets and liabilities as on that day which shall be signed by the partners and copy of which shall be supplied to each partner.
- c) In case of operating banking account or in case of withdrawal of any money or in case of deposit of any money for and on behalf of the said partnership business, the First Party and the Third Party amongst the Parties can jointly operate the banking account and to withdraw or to deposit money for and on behalf of the said partnership business from the respective bank accounts of the said Partnership concern at any time without obtaining any consent of the other partner as because the rests partners hereby vesting such power to

him on behalf of the said Partnership concern.

11. **DEATH :**

In case of death of any partner the partnership shall not be dissolved. The legal representatives of deceased partner shall be entitled to join as a partner and such legal representative shall become such partner in partnership as from the date of demise.

12. **RETIREMENT :**

In case of voluntary retirement which shall be informed in writing by each party before one month and accounts and statements of assets and liabilities thereof shall be taken and made out the share of each partner in the capital and effects of the partnership and of all unpaid interest and profit belonging to them upon the date of retirement shall be determined by the retiring partners of his/her legal heirs shall be paid his/her dues, if any, out of the firm within six month of the account being taken. Similarly, if the accounts and statements of assets and liabilities thereof determine the losses, debit balance of the capital account of the retiring partner in the Balance Sheets or liabilities of the firm upto the date of retirement, the retiring partner shall claim all dues or liabilities standing his/her share and name at the ratio of share of profit and loss within 12(Twelve) months of the account being taken.

13. **RENT & TAX & OTHER EXPENSES:**

The rent of the premises as aforesaid, where the business of the Partnership shall be carried on, and all repairs, additions and alterations and all taxes, rents assessments , payments for insurance against loss by fire and other outgoings for or in respect of the same and the salaries, wages, maintenance of all clerks, workmen, servants who shall be employed in or about the business of the Partnership, and all expenses which shall be incurred in or about the said business and all duties, rates, monies which shall become payable for or upon account of the said business and all losses and damages which shall happen in or account of the said business shall be paid defrayed and born by and out of the capital of the Partnership and the profits thereof , or in case the same shall become deficient ,then by the Partners in equal share.

14. ASSETS AND LIABILITIES :

And the past assets and liabilities of the firm carry by the partners alike profit sharing ratio or by the firm.

17. REGISTRATION

i) No partner shall without consent of other partner in writing (a) Assign or mortgage his/her share or interest of the partnership ; (b) Compound, relinquish or discharge any debt which shall be due of owing to the partnership without receiving the full amount; (c) Dispose of by loan, pledge or sell or otherwise any part of the partnership properties; (d) Draw or accept or endorse any bill of exchange or promissory note on the account of the partnership ; (e) Lend money or given credit to or have and dealings on behalf of the partnership with any person whom the other partner shall have previously forbidden to trust or deal with ; (f) Except in case of gross misconduct, dismiss any person in the employment of the firm; and (g) But any property or goods or articles for the use of the partnership.

(ii) Each Partner shall –

(a) Carry on the business of the firm throughout the Partnership diligently and faithfully and actively employ themselves in and about the business of the Partnership and carry on and conduct the same for the greatest advantage of the Partnership.

(b) Be just and faithful to each other partner and shall render true accounts and full information of all things affecting the firm to the other partner of his/her legal representatives ; and Pay their separate and private debts and indemnify the other partner or the partnership assets against all proceedings, claims, demands or whatsoever in respect thereof.

(c) Not to take any apprentice or hire or dismiss any clerk, salesmen, workmen or servant in the business of the Partnership without the consent of the other Partner and in this respect the decision of the majority will be granted.

- (d) In all cases where there shall be occasion to give any promissory note, bill of exchange, bank guarantee or other security for the payment of any money of account of the partnership the same shall be signed and executed by the partners jointly.
- (e) The Partner authorized and empowered by the other partners shall engage with the person or group of persons or their associates whom the other partner shall previously by notice not forbidden him to trust, for running their said partnership business.
- (f) The Partner authorized and empowered by the other partners shall represent the partnership concern in any contract of supplying building materials, and/or any dealings for getting order for supplying building materials for the progress and development of their partnership business with any person or persons.
- (g) The Partner authorized and empowered by the other partners shall take order from the customer or customers, receive payments from them and issue bill and chalan accordingly.

16. GOODWILL :

At the termination of partnership on the death or retirement of a partner, the goodwill of the partnership shall be valued at the preceding five year's profit.

17. AMENDMENT TO THE AGREEMENT

Any of the terms of this Deed may be revised, deleted, altered, amended or substituted or added to by the mutual consent of the partners in writing.

18. ARBITRATION

Whenever any doubt, difference of dispute shall hereafter arisen between the partners or between one of them and the executors or administrators, or between their respective executors or administrators, touching these presents or the construction hereof, or any

clause or thing herein contained, or any account valuation or division of assets, debts or liabilities to be made as hereinabove is mentioned, or any other thing in anywise relating to or concerning the partnership business or the affairs thereof, or the right duties or liabilities of either party in connection therewith, the matter in difference shall be referred to the two arbitrators or a third arbitrator /Presiding Arbitrator pursuant to , and so as , with regard to the mode and consequence of the reference and in all other respects, to conform to the provisions in that behalf contained in Arbitration and Conciliation Act, 1996 or any statutory modification thereof .

19. PARTNERSHIP ACT, 1932

Save and except what have specifically been stated hereinabove parties shall be governed by the Indian Partnership Act, 1932.
