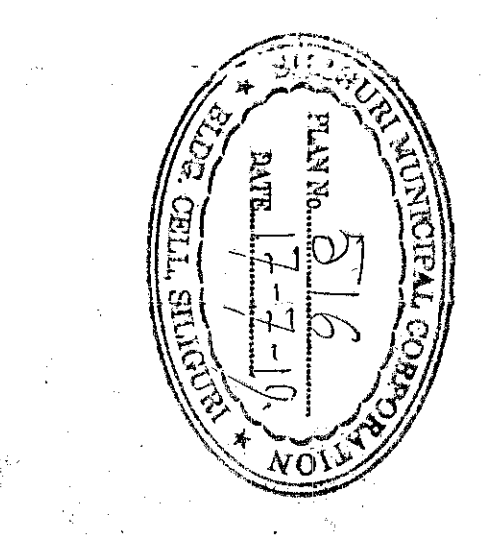

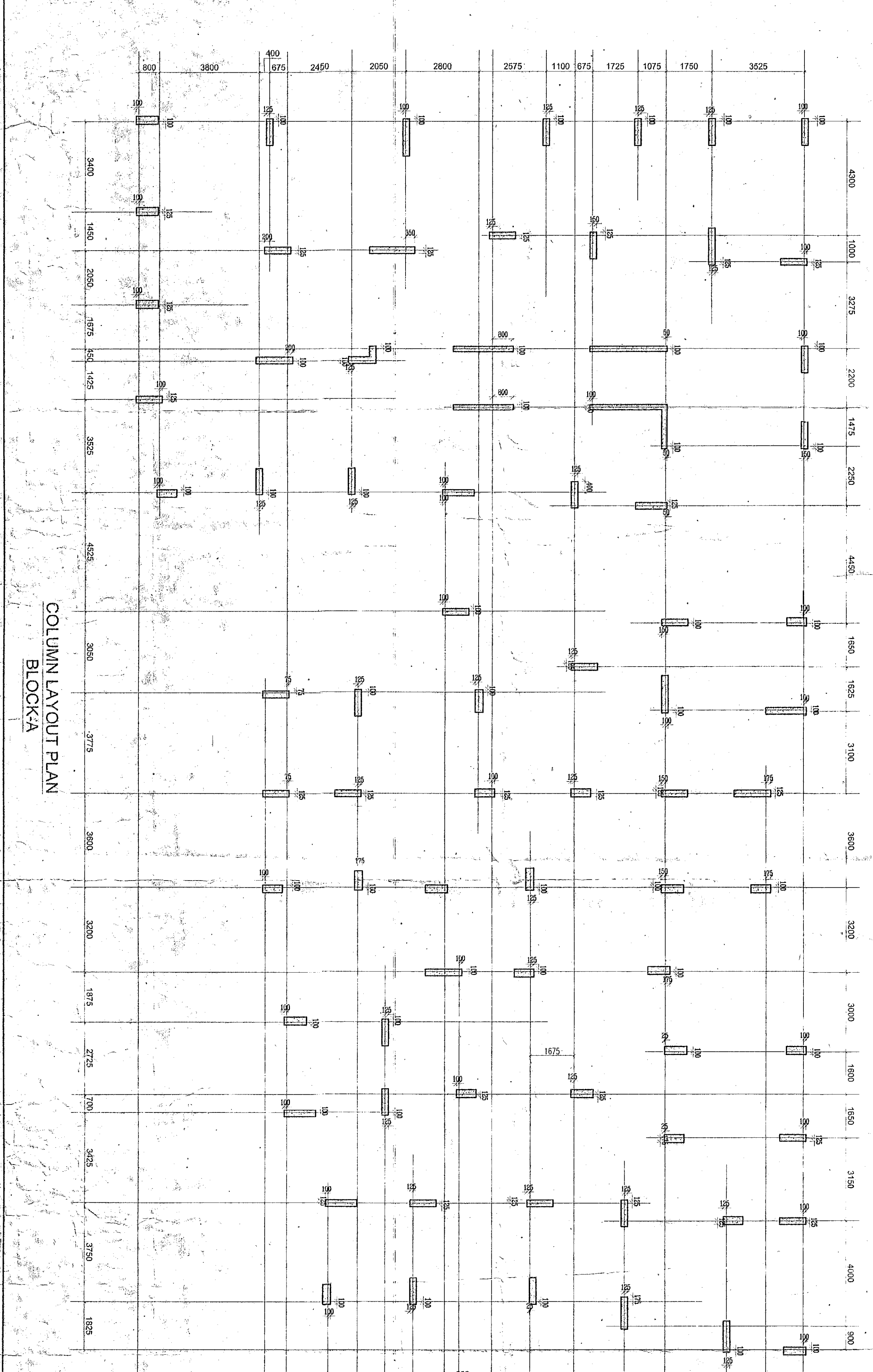
COLUMN LAYOUT PLAN CENTRAL PART
