That I/promoter shall get the accounts audited within tweive months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by the chartered accountant and it shall be verified during the audit that the amount collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That I/promoter shall take all the pending approvals on time from the competent authorities.
- That I/promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That I/promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or the building as the case may be on any grounds.
- 11. That I/promoter shall abide by the provision in section 17 with clause (n) if section 2 relating to common areas.
