5. That the amounts from the separate account, to cover the cost of the project ,shall be withdrawn in proportion to percentage of completion of the project.

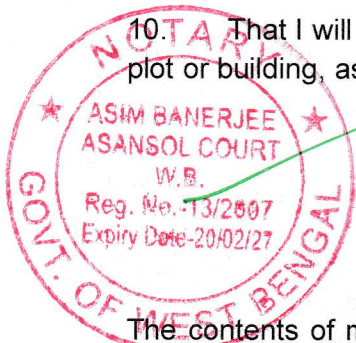
