7. **Powers and Authorities**

- 7.2 **Dealing with Authorities:** To deal with all authorities including but not limited to *Patulia Gram Panchayet* and the Other Authorities for sanction, modification, alteration, extension, revision and re-validation of the Building Plans and obtaining drainage connection, water connection, occupancy certificate and other certificates and in this regard to prepare, sign and submit plans, papers, documents, statements, undertakings, declarations, applications, indemnities and other ancillary papers, as be required.




