- 1. That Bulbul Karmakar & Amal Chandra Karmakar have the legal title to the land on which the development of the proposed project is to be carried out.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by the promoter is $31^{\rm st}$ December, 2024.
- 4.
