- G. Floor, whichever is earlier may be seized forthwith by the K.M.C at the cost and risk of the owner.
- 22.Provision for use of solar energy in the form of solar heater and/or solar photo-cells shall be provided as required under rule 147 of Building rules, 2009 and completion certificate will not be issued in case of building
- without having such provision as applicable.

No deviation from the submitted. Structural plan should be made at the time of erection without submitting fresh structural plan along with design calculation and stability

certificate in the prescribed form. Necessary steps should be taken for the safety of the adjoining premises public

and private properties and safety of human life during construction.
