in office/interest and assigns), hereinafter referred to as the **GRANTORS, DO HEREBY SEND GREETINGS:-**

WHEREAS:

- A. The Grantors herein alongwith South City Projects (Kolkata) Limited, having its registered office at South City Businesspark, Suit No. 711, 770, Anandapur, Kolkata – 700107, are the sole and absolute owners of **ALL THAT** various pieces and parcels of land measuring 46.82 acres (Total Land), lying and situated at Mouzas Bairampur, Kharamba, Ghunimeghi and Korolberia, District South 24 Parganas, as more fully and particularly mentioned and described in the Part I to VI of the First Schedule hereunder written and hereinafter referred to as “Total Land”.
- B. By registered Development Agreement dated 24th September, 2019 made between us, along with South City Projects (Kolkata) Limited, therein referred to as the Land Owners of One Part and South City Projects (Kolkata) Limited, therein as well as herein referred to as the Developer of the Other Part and registered with the Additional Registrar of Assurances- III, Kolkata, recorded in Book No. I, Volume no 1901-2019, Pages from 219634 to 219789, Being No. 05253 for the year 2019 (hereinafter referred to as “the said **Development Agreement**”), we granted and the said Developer accepted exclusive right of development of the said Total Land by constructing and/or developing thereon, Villas and constructed spaces (hereinafter referred to as the RESIDENTIAL AREA) along with Spa, Resort, Community Bazar and other various sports and leisure facilities including the passage ways situated therein (hereinafter referred to as the RESERVED AREA) and also comprising of various pathways, passageways, generator room and various other common parts and portions (hereinafter referred to as the SERVICE AREA) on the terms and conditions therein contained.

- C. Pursuant to and in accordance with the said Agreement, we/grantors had agreed to grant various powers to the said Developer for the purpose of implementing effective and proper development of the said Sanctioned Property in accordance with the terms of the said Agreement including the Power of transferring the proportionate undivided part or share in the land comprised in the said Total Land in favor of the intending transferees.

NOW KNOW BE BY THESE PRESENT that we, the said Grantors do hereby nominate, constitute and appoint the said **SOUTH CITY PROJECTS (KOLKATA) LIMITED (PAN AAACD8933A)**, a company within the meaning of the Companies Act 1956 having its registered office situated at South City Businesspark, Suit No. 711, 770 Andapur, Kolkata - 700107, represented by it's Company Secretary **MR. PARIMAL AJMERA [PAN: AFQPA8865A]**, son of Shri Gunvantrai Ajmera, working for gain at South City Businesspark, Suit No. 711, 770 Andapur, Kolkata - 700107, as our true and lawful Attorney for and in the name and on behalf of ourselves to do execute exercise and perform all or any of the following acts deeds matters and things relating to the said "Total Land" in the manner as more fully hereinafter contained:

1. To take all the necessary steps, execute, sign, submit and receive all the documents which may be required for obtaining, all permissions, clearances, approvals and sanctions from the various authorities including the final sanctioned building plan from the Local Gram Panchayat/South 24 Parganas Zila Parishad or from any other competent authority in respect of the "Total Land"

2. To take all the necessary steps and/or to sign all the necessary documents and also to pay the sanction fees, charges for obtaining and receiving the final/revised sanction plan, from the competent authority.
3. To take all the necessary steps like appointing Architects, Engineers, Surveyors, Contractors, Soil Test Agency and other consultants, as may be necessary for development of the "Total Land" and to make the payment of their fees/charges.
4. To take all the necessary steps for marketing and selling of the Villas to be constructed on the "Total Land" and for that purpose to do the booking and / or enter into an agreement for sale and allot the Villas to such prospective purchaser/s, and receive the advance against the consideration amount from such prospective purchaser/s.
5. To appropriate and/or disburse, in terms of the Development Agreement, the advance amount and/or sale consideration amount received from the prospective purchaser/s.
6.
