

Report in the matter of M/s. Dhar Galvanizing Works (1955) Pvt. Ltd., 92, Bidhan Nagar Road, Kolkata-700067.

M/s. Dhar Galvanizing Works (1955) Pvt. Ltd. was a manufacturing unit of drums and containers having its registered office and factory at 92, Bidhan Nagar Road, Kolkata-700067. The management of the said unit declared (by notice) closures w.e.f. 01.12.2010 after settling the issue of full and final payment to the all the workmen of the unit.

On verification of papers submitted by the management the representative of the workmen along with other workmen, were heard and it was found that 9 (nine) workmen out of eleven have left the company of their own in 2007 by tendering resignation, after having accepted the payment of gratuity from their employer reportedly for better scope of employment elsewhere. It is also reported by the said workmen that the company remained closed for the year i.e. 16.04.2007 to 01.04.2008 for its sickness and reopened in 2008.

On 01.04.2008, 7 (seven) employee who had worked earlier with the management joined the company as fresh entrants and continued up to 30.10.2010. Those 7 employees were paid wages up to 30.10.2010 and compensation for the period 01.04.2008 to 30.10.2010.

The company issued notice of closure on 31.10.2010 and closure effected from 01.12.2010 and the company surrendered the factory licence and it was accepted by Chief Inspector of Factories on 02.02.2012.

The workmen have also stated that there is no dues etc. from the management.

As such there is no dispute pending before this authority in respect of any claim on whatsoever in nature at present
