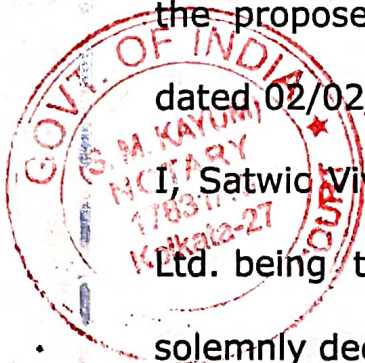



1. That the Owners have a legal title to the land on which the development of the proposed project at 54A, Hazra Road, Kolkata 700 019, PS Gariahat has been carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoters for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances.
