We have audited the accompanying financial statements of **SWASTIC PROJECTS PRIVATE LIMITED** ("the Company"), which comprise the Balance Sheet as at 31<sup>st</sup> March, 2021, and the Statement of Profit and Loss for the year then ended, and a summary of the significant accounting policies and other explanatory information.






