BETWEEN

SRI PRAKASH MUNDRA, son of Sri Prayag Chand Mundra, Hindu by Religion, Indian by Nationality, Business by Occupation, Permanent Resident of Mundra Building, M.G. Marg, P.O. Gangtok, P.S. Sadar Thana, District East Sikkim-737101, Presently Residing at Sevoke Road, P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri, Pin Code-734001 - hereinafter referred to and called as the "DONOR" (which expression shall mean and include his heirs, executors, administrators, legal representatives and assigns) of the "ONE PART".

AND

SRI RAVI MUNDRA, son of Sri Prayag Chand Mundra, Hindu by Religion, Indian by Nationality, Business by Occupation, Permanent Resident of Mundra Building, M.G. Marg, P.O. Gangtok, P.S. Sadar Thana, District East Sikkim-737101, Presently Residing at Sevoke Road, P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri, Pin Code-734001- hereinafter referred to and called as the "DONEE" (which expression shall mean and include his heirs, executors, administrators, legal representatives and assigns) of the "OTHER PART".

WHEREAS the abovenamed Sri Prakash Mundra (the Donor hereof) had purchased land measuring about 0.2725 Acre from J. Uttam Industries, a Partnership Firm, represented by its partner, Sri Dulichand Sethia, by virtue of a registered Sale Deed dated 05.03.1992, being Document No. I-1476 for the year 1992 and the same was registered in the Office of the Addl. District Sub Registrar, Jalpaiguri.

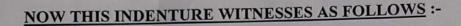
