1. This Certificate is non-transferable.

The developer shall take up plantation of trees over226 sq. mt (subject to a minimum of 5 times the trees, if any, to be felled) in the same plot(s) of the land being developed in accordance with the approved plantation plan and complete the same within6 (six).... Month(s) from the date of sanction of the building / construction plan by the sanctioning authority.
