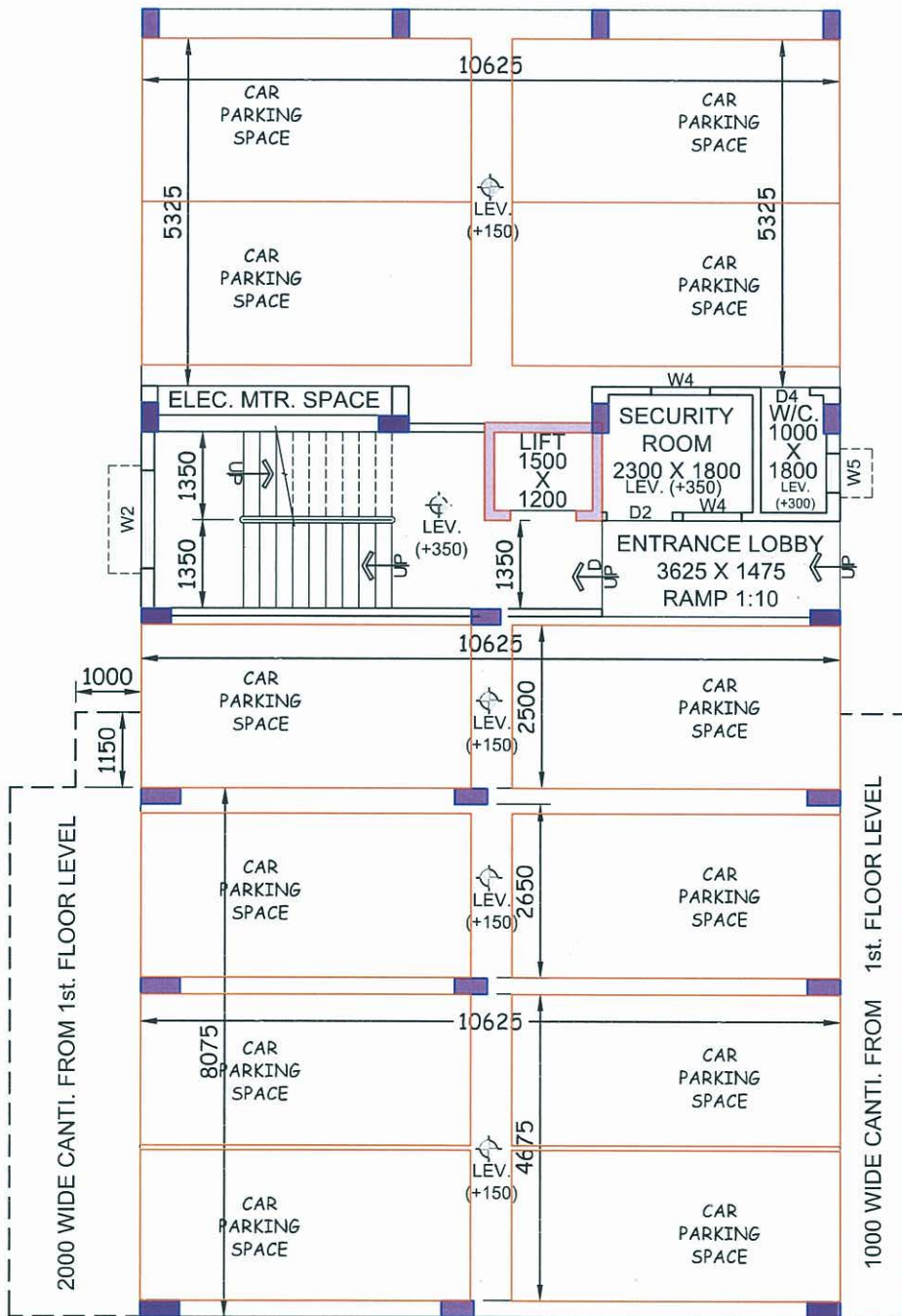

GROUND FLOOR PLAN

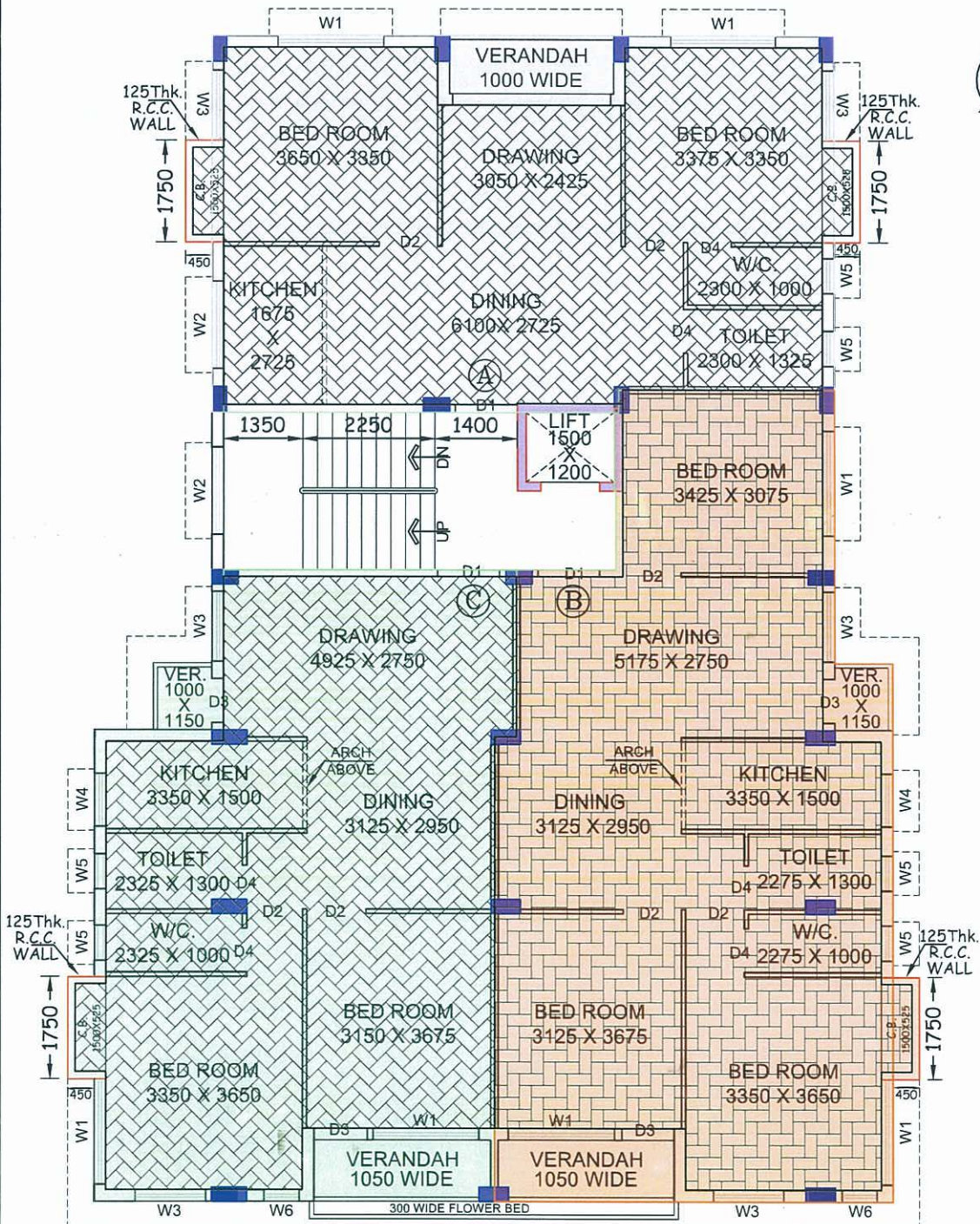

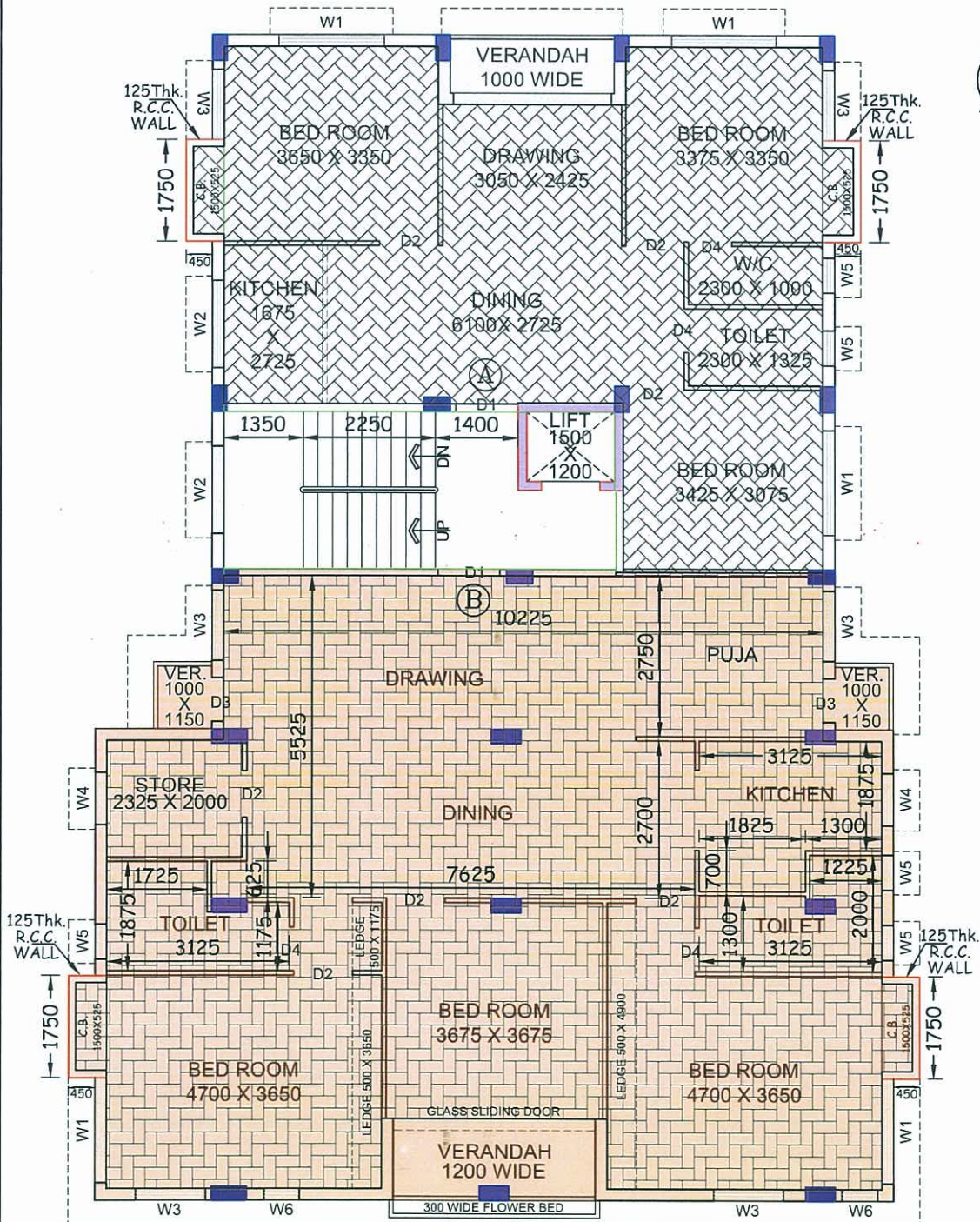
FIRST, THIRD & FOURTH FLOOR PLAN
