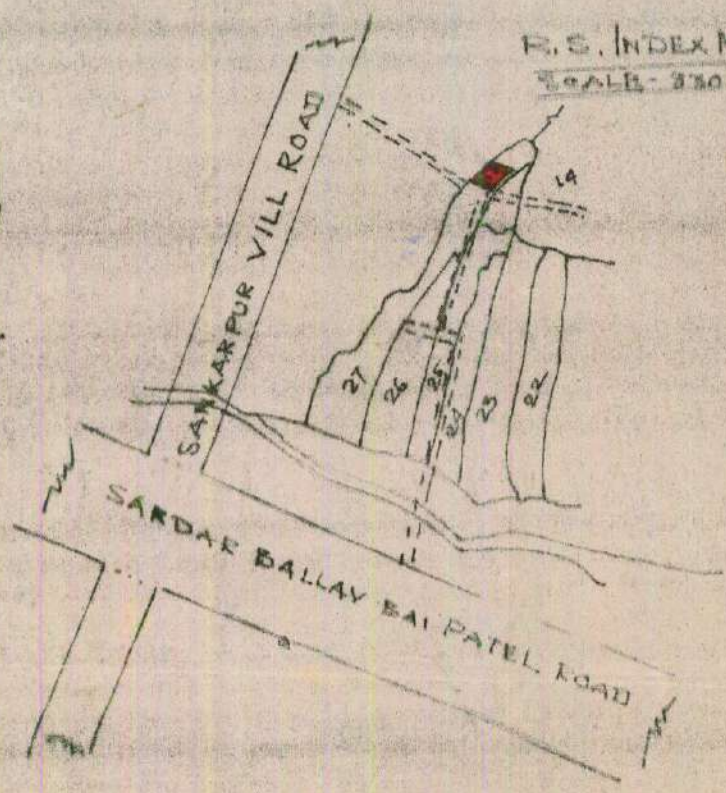
PLAN SHOWING THE LAND OVER PART OF R.S.

# গতির দাবি পরিবারের



দোকানে প্রায় ১১ হাজার, ট্রাক্টরে প্রায় সাড়ে ছয় হাজার টাকা সেনা ছিল বলে এখনও পর্যন্ত জানতে পেরেছি।" মুতের স্ত্রী জয়ন্তী মণ্ডলের দাবি, চাষে সেনার কারণে মানসিক ভাবে বিপর্যস্ত ছিলেন স্বামী। পাণ্ডানারেরা বাড়িতে এসে তাগাদা দিত। টাকা চাইত। এ নিয়ে স্বামীর সঙ্গে অশান্তিও হত। এই সব কারণেই তিনি আত্মহত্যা করেছেন, দাবি তাঁর।

স্বপনের স্ত্রী ও দুই ছেলে ছুটমিলে কাজ করেন। বাড়িতে গিয়ে দেখা যায় শোকের আবহ। তাঁরা ক্ষতিপূরণের দাবি জানিয়েছেন। বিডিও (সদর-২) সুবর্ণা মজুমদার বলেন, "বিষয়টি সুনাম। কেন এই আত্মহত্যার ঘটনা ঘটল, সেটা খতিয়ে দেখা হবে।"

দুই-পাঁচবার পুলিশের কেরতুগ্রামের সেরান্দি গ্রামে বাদশাহী রোডে দুর্ঘটনাটি ঘটে। মুতরা হলেন, চাঁদ শেখ (৬৪), মদন মল্লিক (৭০) ও বাদশাহ মল্লিক (৪২)। মদন বাদশাহের বাবা। বাদশাহের স্ত্রী আদুরি বিবি ও চালক পারভেজ হোসেনকে রক্তাক্ত অবস্থায় প্রথমে কান্দরা গ্রামীণ হাসপাতালে ভর্তি করানো হয়। পরে অবস্থার অবনতি হলে কাটোয়া মহকুমা হাসপাতালে পাঠানো হয়। প্রত্যেকেরই বাড়ি মুর্শিদাবাদের বড়ঙ্গা থানার পুলিশি গ্রামে।

পুলিশ ও স্থানীয় সূত্রে জানা গিয়েছে, বাবাকে চিকিৎসা করাতে একটি ছোট গাড়ি ভাড়া করে বর্ধমানে গিয়েছিলেন বাদশাহী। বেলা সাড়ে ১১টা নাগাদ গাড়ি করে বর্ধমান থেকে বাদশাহী রোড ধরে বাড়ি ফিরছিলেন তাঁরা। পথে কেরতুগ্রামের সেরান্দি দিঘির পাড়ের কাছে একটি গাড়িকে পাশ কাটানোর সময়ে উপ্তো দিক

দেখা প্রত্যেকেই রক্তাক্ত অবস্থায় পড়ে রয়েছেন। তিন জন ঘটনাস্থলেই মারা যান।" কেরতুগ্রামের বিধায়ক শেখ সাহানেওয়াজ বলেন, "মর্মান্তিক। আমাদের কর্মীরা আহতদের দ্রুত চিকিৎসার জন্য সব রকমের ব্যবস্থা নিয়েছেন।" পুলিশ জানিয়েছে, দুটি গাড়িই আটক করা হয়েছে।

বাদশাহর বোন মদিনা বিবি বলেন, "খুব গরিব আমরা। দাদা বাবসা শুরু করার পর থেকে বাড়িতে সুখের মুখ দেখা গিয়েছে। কিন্তু সেই সুখ সহ্য হল না। বাবা ও দাদা এক সঙ্গে চলে গেল।" চাঁদের মেয়ে সার্জিনা বিবিও বলেন, "বাবা বাদশাহদার সঙ্গে বর্ধমানে চিকিৎসা করাতে গিয়েছিল। কিন্তু এ ভাবে তিন জনের মৃত্যু হবে সেটা ভাবতেই পারছি না।" হাসপাতাল সূত্রে খবর, গাড়ির চালক পারভেজ ও বাদশাহ স্ত্রী চম্পার অবস্থাও আশঙ্কাজনক। নিজস্ব সংবাদদাতা
