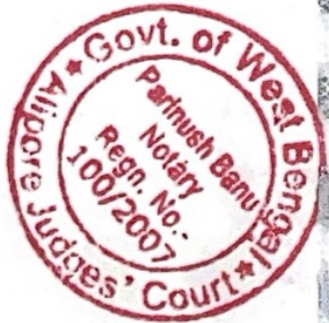
AFFIDAVIT

1. That, my mother Biva Das wife of Late Sunil Kumar Das, died intestate on the 20th day of August, 2001 leaving behind her only one son myself named Sri Subin Das and only daughter Shamita Das Dasgupta.

2. That, our father Sunil Kumar Das as aforesaid also died intestate on the 6th May, 2013.
3. That our aforesaid deceased mother was the absolute owner of a two storied building with appertaining land situated at 29/3, Durga Prasanna Paramhansa Road, at Naktala, P.S. Garia, Kolkata-700077, (hereinafter known as "Estate Biva Das").
4. That, so far no application for succession certificate or Letters of Administration has been made by us or by any other person to any court whatsoever, in respect of the Estate of the said deceased.
5. That, after the death of our said deceased mother I became the Karta of the said joint family Estate and my only sister has become the other members of the Joint Family in respect of that Estate Biva Das.



6. That, my sister Samita Das Dasgupta by an affidavit before the Notary Public at Alipore on 20th day of January, 2016 withdraw her claim in the 50% of the said Joint Estate and declared that she has no right, title, interest whatsoever in future over the above mentioned Estate of Biva Das and thereby authorised and empowered me to handle, manage and deal in whatsoever manner he thinks right and proper and I shall not make her responsible whatsoever in future.
