DEED OF CONVEYANCE

THIS INDENTURE OF CONVEYANCE is made on this the 10th day of June Two Thousand Thirteen (2013),

BETWEEN

(1) HANNAN SHA (2) MANNAN SHA (3) RAHAN SHA (4) SAHAN SHA (5) OMAR ALI SHA all sons of Late Sekender Sah all residing at Village- Langolpota, P.O. Matiagacha, P.S. Barasat, Kolkata- 700135, in the District of North 24 Parganas, all by faith- Muslim, by occupation – Cultivation, all by Nationality- Indian, hereinafter jointly called and referred to as the *VENDORS* (which expression shall unless excluded by or repugnant to the context be deemed to mean and include their and each of their legal heirs, executors, administrators, representatives nominees and assigns) of the *ONE PART*.

- AND -

(1) RAFIKUL SA alias RAFIK SHA son of Late Faim Sha (2) MEKAIL SHA (3) SARIFUL SHA (4) REZAUL SHA all sons of late Saha Alam Sha alias Sa Alam Sa, (5) REHANA BIBI (6) SAHANARA BIBI both daughters of late Saha Alam Sha alias Sa Alam Sa (7) ANURA BIBI wife of late Saha Alam Sha alias Sa Alam Sa, all residing at Village- Langolpota, P.O. Matiagacha, P.S. Barasat, in the District of North 24 Parganas, Kolkata- 700135, all by faith Muslim, by occupation- Cultivation and Housewives, all by Nationality- Indian, hereinafter jointly called and referred to as the *CONFIRMING PARTY* (which expression shall unless excluded by or repugnant to the context be deemed to mean and include their and each of their legal heirs, executors, administrators, representatives nominees and assigns) of the *SECOND PART*.

- AND -

GLF PROJECTS LIMITED, a Company, incorporated under the Provisions of the Companies Act. 1956, having its Office at 23A, N.S. Road, 4th floor, Room No. 7A, Kolkata- 700001, P.S. Hare Street, represented by its Director *SRI ROSHAN LAL SINGHAL* son of Late Chander Bhan Singhal, by faith- Hindu, by occupation- Business, by

Nationality- Indian, hereinafter called and referred to as the **PURCHASER** (which expression shall unless excluded by or repugnant to the context be deemed to mean and include its Director in office for the time being in force, executors, administrators, representatives and assigns) of the **THIRD PART** ;

WHEREAS :

A) One **Smt. Prohabati Haldar** wife of Late Manindra Lal Haldar alias Mahendra Nath Haldar of Basina, P.S. Rajarhat, in the District of North 24 Parganas, referred therein as the Vendor sold transferred and conveyed her right title and interest of a plot of Sali land measuring an area of **50 Satak** be the same a little more or less as 0.2500 share out of total 2 Acre comprised in **R.S. Dag No. 5174**, under **R.S. Khatian No. 190** lying and situated at **Mouza- MATIAGACHA**, J.L. No. 187, R.S. B) While seized and possessed of the aforesaid plot of land, measuring an area of **50 Satak**, the said **Abdul Gani Molla** referred therein as the Vendor sold transferred and conveyed his right title and interest of a portion from the same measuring an area of **10 (ten) Satak** out of said 50 Satak total out of 2 Acre comprised in **R.S. Dag No. 5174**,

under **R.S. Khatian No. 190**, lying and situated at *Mouza-MATIAGACHA*, J.L. No. 187, R.S. No. 17, Touzi No. 146, within the local limits of Kirtipur 2 No. Gram Panchayet, within the jurisdiction of Barasat Police Station, in the District of North 24 Parganas to 1) **HANNAN SHA** (2) **MANNAN SHA** (3) **RAHAN SHA** (4) **SAHAN SHA** (5) **OMAR ALI SHA** all sons of Late Sekender Sah all resident of Village- Langolpota, P.O. Matiagacha, P.S. Barasat, Kolkata- 700135, in the District of North 24 Parganas (the **Vendor Nos. 1 to 5 herein**) referred therein as the Purchasers, by a registered Deed of Sale (Bengali language- Suff Kobala) registered at A.D.S.R. Office- Barasat North 24 Parganas and recorded in Book No. I, Volume No. 81, Pages 153 to 158, Being No. 4266, in the year 1999 on 21.06.1999, against valuable consideration mentioned thereon.

C) Since then, the Vendor Nos. 1 to 5 herein are jointly seized and possessed of the aforesaid plot of land measuring an area of **10 (ten) Satak** more or less out of 50 Satak total out of 2 Acre comprised in **R.S. Dag No. 5174**, under **R.S. Khatian No. 190**, lying and situated at *Mouza- MATIAGACHA*, J.L. No. 187, R.S. No. 17, Touzi No. 146, within the local limits of Kirtipur 2 No. Gram Panchayet, within the jurisdiction of Barasat Police Station, in the District of North 24 Parganas, by virtue of above purchase and have been enjoying the same as per demarcation peacefully, freely, absolutely and without any interruptions from any corners whatsoever by paying usual rents and taxes to the proper authorities in their names as absolute owners and possessors thereof and have the full right to dispose or transfer the same to any body in any way as they will think fit and proper.

D) Now the Vendor Nos. 1 to 5 herein have agreed to sell and the Purchaser herein has agreed to purchase the said plot of land measuring

NOW THIS INDENTURE WITNESSETH THAT in pursuance of the said agreement and in consideration of *Rs. 4,85,000/- (Rupees four lacs eighty five thousand) only* of the lawful money of the Union of India in hand and well and truly by the Purchaser to the Vendors paid at or before the execution hereof (the receipt whereof the Vendors doth hereby as also by the receipt and Memo of consideration hereunder written admit and acknowledge and of and from the payment of the same and every part thereof forever release discharge and acquit the Purchaser and the properties benefits and rights hereby granted sold, conveyed transferred assigned and assured or expressed or intended so to be) the Vendors doth hereby grant sell, convey transfer assign and assure unto and in favour of the Purchaser herein **ALL THAT** the said plot of land measuring an area of 10 (ten) Satak more or less out of total 2 Acre comprised in R.S. Dag No. 5174, under R.S. Khatian No. 190, lying and situated at *Mouza- MATIAGACHA*, J.L. No. 187, R.S. No. 17, Touzi No. 146, within the local limits of Kirtipur 2 No. Gram Panchayet, within the jurisdiction of Barasat Police Station, in the District of North 24 Parganas, more fully and particularly described in the Schedule hereunder written and hereinafter referred to as '**the SAID LAND**' together with all and singular the tangible and intangible assets edifices fixtures gates courts courtyards compound boundaries, areas sewers

drains ways paths passages fences hedges ditches trees water courses lights and all manner of former and other right liberties benefits privileges easements appendages and appurtenances whatsoever belonging or in any way appertaining thereto or reputed or known to be part or parcel of member thereof which now is or are or hereto before were or was held used occupied or enjoyed therewith AND reversion or reversions remainder or remainders and rents issues and profits thereof and all and every part thereof AND all the Raiyati and entire share estate right title interest inheritance use trust possession property claim easements quasi easements privileges claims and demands whatsoever of the Vendors out of or upon the properties benefits and rights hereby granted sold, conveyed transferred assigned and assured or expressed or intended so to be TOGETHER WITH all deeds paths muniments writings and evidences of title in anywise relating to or connected with the said property or any part thereof which now are or is or hereafter may be in possession power custody or control of the Vendors or any person or persons from whom the Vendors or any of them may procure the same without any action or suit at law or in equity TO HAVE AND TO HOLD the same unto and to the use of the Purchaser absolutely and forever for a perfect and indefeasible estate of inheritance in fee simple in possession without any manner of condition use trust or other thing whatsoever to alter defeat encumber or make void the same and free from all encumbrances mortgages charges leases tenancies occupancy rights liens lispendences attachments bargaders trusts claims demands acquisition requisition vesting alignment claims demands and liabilities whatsoever or howsoever.

THE VENDORS DO TH HEREBY COVENANT WITH THE PURCHASER:

1. That free and clear and freely and clearly and absolutely acquitted exonerated and release or otherwise by and at the cost and expenses of the Vendors are and sufficiently entitled, and saved defended kept harmless and other easement rights title claim mortgage liens lispendences, attachments whatsoever.
2. That the purchaser shall hereinafter peacefully and quietly possess and enjoy the said property in khas without any claim or demand whatsoever from the Vendors or their legal heirs, executors, administrators, representatives, nominees and assigns.
3. That no notice issued under the public demand recovery act has been served on the Vendors not any such notice has been published.
