Sabita Kar**, wife of Late Paresh Chandra Kar, all by faith-Hindu, by Nationality-Indian, by occupation-Housewife, residing at L.O.P.No.1452 of Garia Laskarpur G.S.Colony, Block-C, presently at Uttar Sripur, P.O.Boral, P.S.Narendrapur(viously Sonarpur), Kolkata-700154, District-South 24-Parganas, do hereby solemnly declare and affirm:

1. That the Governor of the State of West Bengal gave the homestate land measuring 4 Cottahs situated and lying at Mouza-Sripur Bagerghol ,J.L.No.59 comprising in C.S. / R.S.Plot No.211(P) L.O.P.No.1452, P.S.Sonarpur, District-South 24-Parganas by registered deed of gift executed on 12/10/2007 & completion on 29/1/2007 in favour of Sri Nirmal Kanti Paul and Smt. Sabita Kar(Deponent No.3 herein) registered at A.D.S.R.office at Alipore and recorded in Book No.I, Volume No.IV, Pages-69 to 72, being No.618 for the year 2007.



2. That by registered deed of gift, the said Sri Nirmal Kanti Paul & Smt. Sabita Kar (Deponent No.3 herein) became the absolute joint owners of the lane measuring 4 Cottahs situated and lying at Mouza-Sripur Bagerghol ,J.L.No.59 comprising in C.S. / R.S.Plot No.211(P) L.O.P.No. 1452, P.S.Sonarapur, District-South 24-Parganas(hereinafter called the said property).

3) That at time of B Form of Mutation of Rajpur-Sonarapur Municipality, the said property obtained two holding without partition of which Holding No.533 Uttar Sripur, ward No.33 belongs to Sri Nirmal Kanti Paul and Holding No. 141 Uttar Sripur, Ward No.33 belongs to Smt. Sabita Kar.

4) That the said Nirmal Kanti Paul and Smt. Sabita Kar (Deponent No.3 herein) jointly residing at the above said property.

5) That the said Nirmal Kanti Paul died intestate on 14/12/2018 leaving behind him wife, Smt. Kalyani Paul (Deponent No.1 herein) and one daughter, Smt.Papiya Sudhukhan (Deponent No.2 herein) as his sole legal heirs and successors.

5) That the said two holdings, i.e. 533 & 141 may please be amalgamated and the total area i.e more or less 4 Cottahs 00 Chattaks 0 Sq.ft. as mentioned above and also shown in the map or plan annexed hereto by RED border be treated and numbered as a single plot/holding, i.e. 533 because the said property being the joint owners and there is no partition of the aforesaid property. (Butted and bounded of the aforesaid Property :- on the North:- L.O.P.No.1451, on the South :- L.O.P. No.1400, on the East :- 25 ft wide Road, On the West :- L.O.P.No.1900 Tank

6) That in future we shall never pray for separation of the holding or be separate and if in future any dispute arises for the said amalgamation the said Municipality will not be responsible in any way.

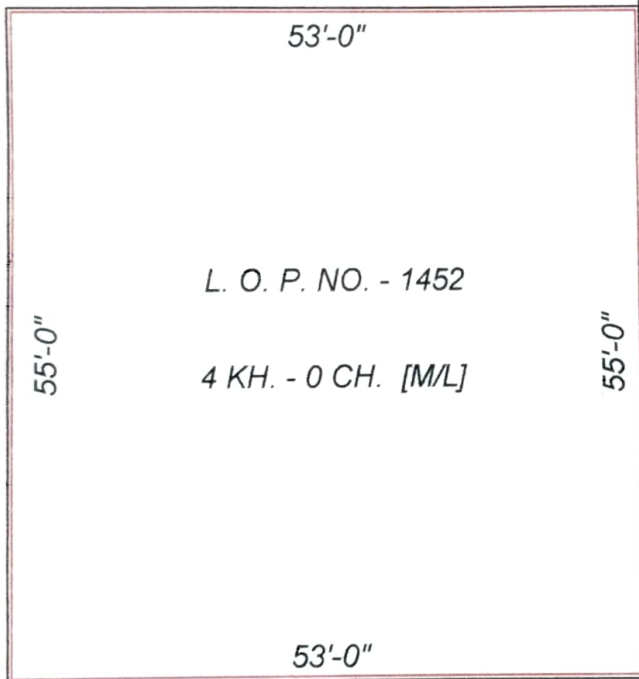
LAND AREA SHOWN IN RED BORDER
