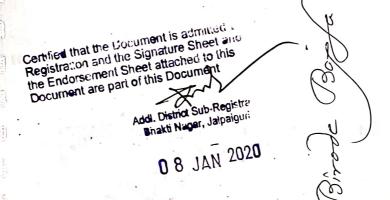

WHEREAS the abovenamed SRI BINODE BAJLA (the DONOR herein) has purchased all that piece or parcel of land measuring 1 Bigha 18 Katha 5 Chattak or 0.6321 Acre from Sri Shekhar Kundu and Smt. 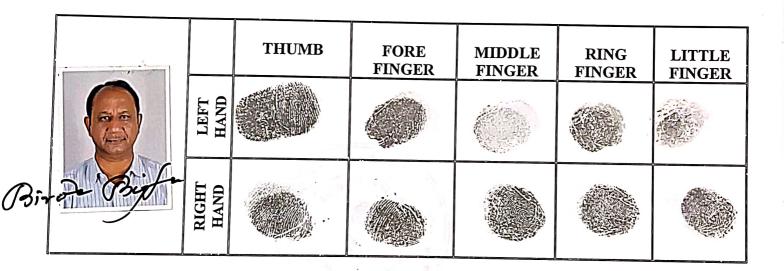
