 2) Owners of the premises shall have to maintain all water fittings to prevent stagnation due to leakage & drain off water once a week from underground & overhead reservoirs and covered properly with well fitted lids for safeguard against contamination and mosquito breeding. Non-compliance may lead to cut off water connection u/s 275(b) of CMC Act, 1980 and will be treated as offence u/s 496 of the CMC Act. Ball cock is to be installed at underground reservoir to save water. It is also encouraged to install automatic pump tripping arrangement to avoid overflow from overhead reservoir.

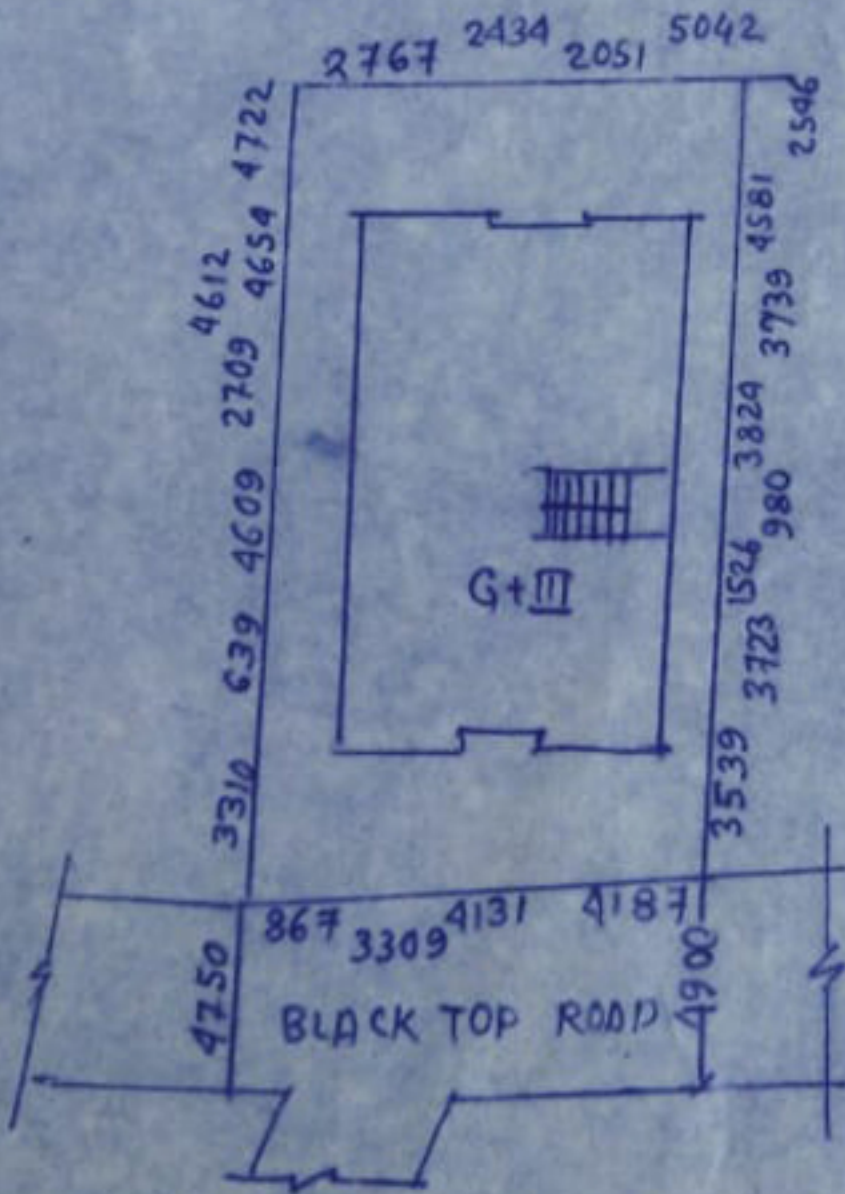
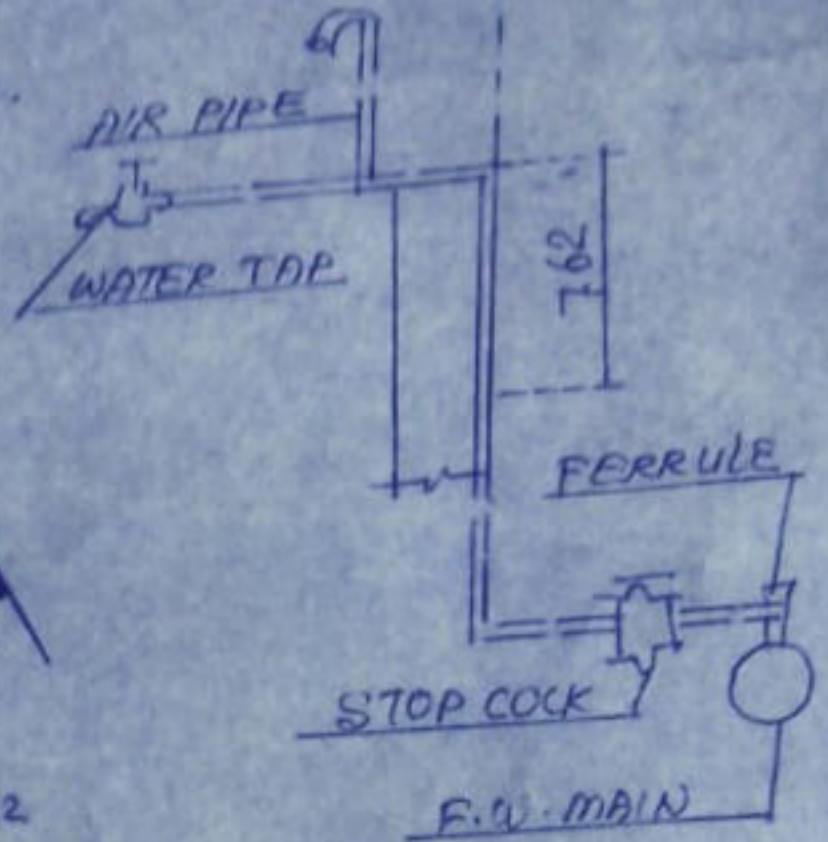
