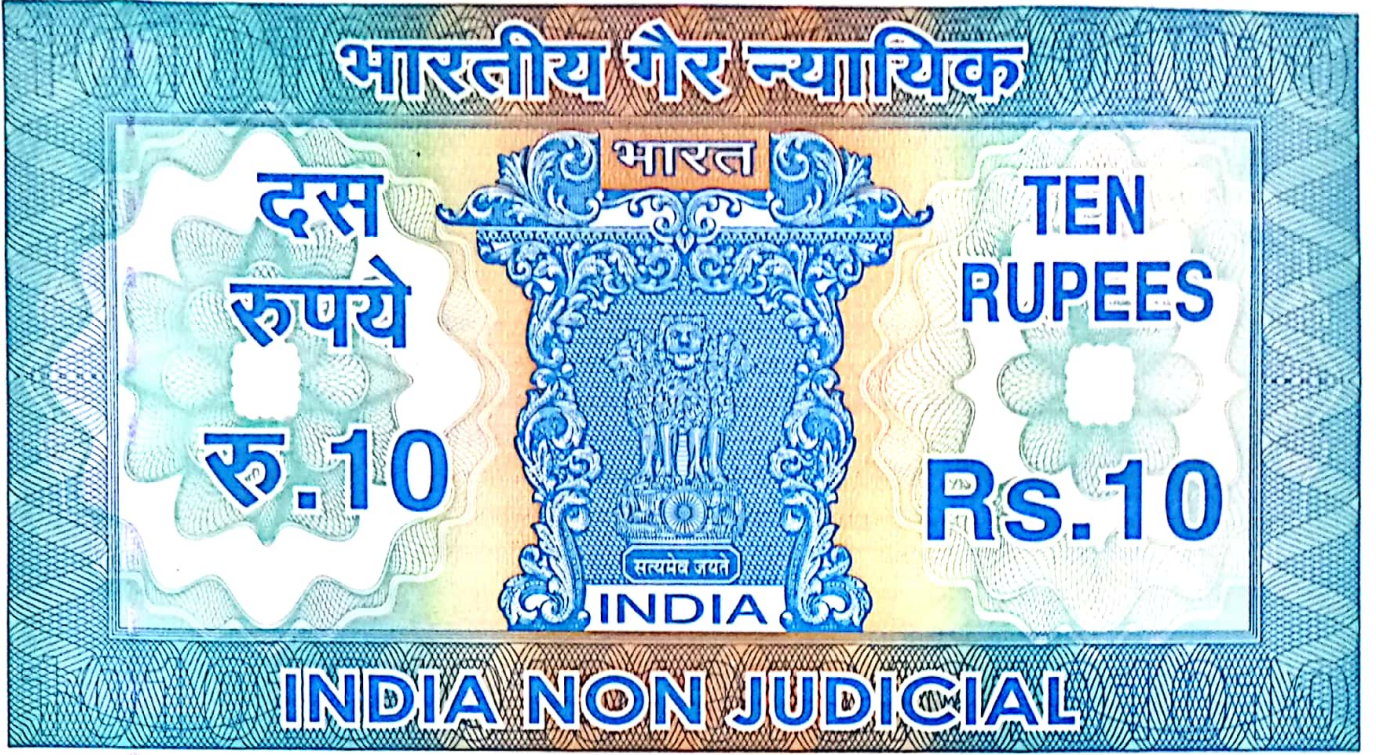

5. That the amount from the separate account, to cover the cost of project shall be withdrawn in proportion to the percentage of completion of the project.
6. That the amount from the separate account , that the withdrawn after its certified by an engineer an architect and a chartered accountant in practice , that the withdrawal is proportion to ,the percentage of completion of the project .
7. The promoter shall get the account audited within six month after the end of every financial year by a chartered accountant in practice and shall produce a statement of account duly certified and sighed by such chartered accountant and it shall be verified during the audit that the amount collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion of the percentage completion of the project .
