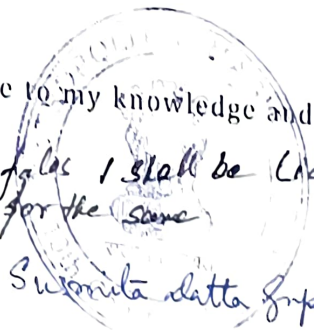
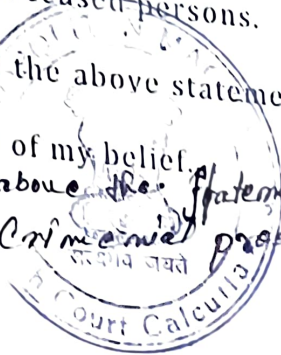

That originally Debkumar Das Gupta became the absolute owner by way of Deed of Indenture dated 22<sup>nd</sup> day of April, 1959 vide Book no. 1, Vol. no. 61, pages 172 to 179, being no. 4027 for the year 1959, which was registered in the office at Sub Registrar at Alipore, in respect of land measuring 3 cottahs, 3 chittaks, 2 sq. ft. lying and situate at K.M.C. premises no. 3A Thakurbari Road, P.S. Tollygunge, Kolkata 700026, Ward No. 84, being Assessee no. 110842200283 and 3B, Thakurbari Road, P.S. Tollygunge, Kolkata 700026, Ward No. 84, being Assessee no. 110842200295.
2. That Debkumar Das Gupta during his life time he made a Registered Will dated 27.05.1983. After demise of Deb Kumar Das Gupta his wife Latika Das Gupta as an executrix filed a probate case being no. Act. 39 287 of 1992 (Probate) before the Ld. District Delegate at Alipore and granted probate on 12.01.1995 in respect of the aforesaid property.
3. After demise of Debkumar Dasgupta intestate leaving behind his legal heirs his wife Latika Dasgupta, one son namely Rana Dasgupta, and one daughter namely Susmita Datta Gupta
4. The said Latika Dasgupta was died on 01.01.2001 intestate leaving behind her legal heirs her son Rana Dasgupta, and daughter Susmita Datta Gupta.
