8. That I shall take all the pending approvals on time from the competent authorities.

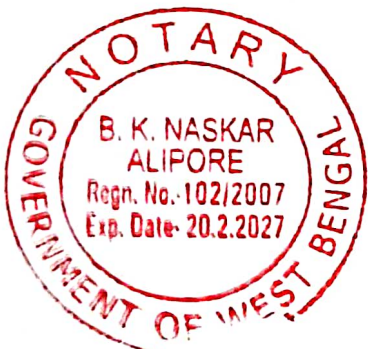
