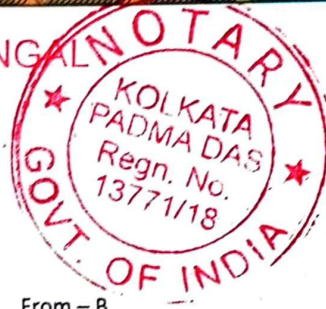

4.
