AND WHEREAS by an indenture dated 2nd day of July, 1951 **BETWEEN** Debendranath Rakshit, Dwijapada Rakshit and Bamanpada Rakshit all sons of Nrityagopal Rakshit (deceased) as the Donors therein of One Part and Sudhir Kumar Rakshit, Sushil Kumar Rakshit and Sisir Kumar Rakshit all sons of Nagendra Nath Rakshit (deceased) son of Late Nrityagopal Rakshit of the Other Part as Donee, the Donors have transferred their each $1/4^{\text{th}}$ share from their share of 1181.25 sq.ft. out of total area 1575 sq. ft.. The said donors holding their shares i.e. 885.94 sq. ft. approximately and said donees are holding their shares of 295.31 sq. ft. of under mentioned schedule property. The said Sudhir Kumar Rakshit, Sushil Kumar Rakshit and Sisir Kumar Rakshit have been recorded their names in the Assessment Book of Kolkata Municipal Corporation as Assessee.

AND WHEREAS Jitendra Nath Rakshit (deceased) was the owner of $1/4^{\text{th}}$ share i.e. 393.75 sq. ft. out of total area 1575 sq. ft. (measuring an area 2 Cottah, 3 Chittak) of the under mentioned dwelling house schedule property at Premises No. 258, Vivekananda Road, Kolkata.

AND WHEREAS the said Debendranath Rakshit, Dwijapada Rakshit and Bamanpada Rakshit (donors) have retained their shares 295.31 sq. ft. each from an area of 885.94 sq. ft. more or less out of total area of 1575 sq.ft and the said Sudhir Kumar Rakshit, Sushil Kumar Rakshit and Sisir Kumar Rakshit (donee) became the owner of each share 98.44 more or less from their share of 295.31 sq. ft. out of total area 1575 sq. ft.

AND WHEREAS the Jitendra Nath Rakshit is the owner of 393.75 sq. ft., Debendranath Rakshit is the owner of 295.31 sq. ft., Dwijapada Rakshit is the owner of 295.31 sq. ft., Bamanpada Rakshit is the owner of 295.31 sq. ft., Sudhir Kumar Rakshit is the owner of 98.44 more or less, Sushil Kumar Rakshit is the owner of 98.44 more or less and Sisir Kumar

Rakshit is the owner of 98.44 more or less out of total area 1575 sq. ft. (i.e. two cottahs and three chittaks)

AND WHEREAS on 27-01-1962 Jitendra Nath Rakshit died intestate leaving behind his wife and one son namely Bimal Kumar Rakshit and one granddaughter namely Sreerupa Mitra and one grandson namely Sreekumar Rakshit. According to Will dated 07-05-1958 of Jitendra Nath Rakshit the ownership of proportionate share of under-mentioned schedule property will be vested equally upon his son Bimal Kumar Rakshit and granddaughter of Sreerupa Mitra.

AND WHEREAS on 23-04-1963 the Bimal Kumar Rakshit died intestate leaving behind his legal heirs Maya Rakshit-Wife, Sreerupa Mitra-daughter and Sreekumar Rakshit-son. The proportionate share of Bimal Kumar Rakshit i.e. 50% share of under mentioned schedule property was bequeathed by Late Jitendra Nath Rakshit vide Will dated 07.05.1958 and vested to his wife Maya Rakshit, daughter-Sreerupa Mitra and son Sreekumar Rakshit equally having $1/3^{\text{rd}}$ share each.

AND WHEREAS on 31-12-2010 Maya Rakshit wife of Late Bimal Kumar Rakshit died intestate leaving behind her one son and one daughter viz. Sreekumar Rakshit and Sreerupa Mitra and the proportionate $1/3^{\text{rd}}$ share of Maya Rakshit has inherited equally by her said daughter and son. The said Sreerupa Mitra and Sreekumar Rakshit are joint Assessee as per records of Assessment Book of Kolkata Municipal Corporation.

AND WHEREAS Debendra Nath Rakshit was one of the proportionate shareholder of under-mentioned schedule property and he was one of the Assessee in the Office of the Kolkata Municipal Corporation under ward No.28 being Assessee No.11-028-17-0041-8 at premises No.258, Vivekananda Road, Kolkata-700006. That after the death of Debendra

Nath Rakshit his only wife Lilabati Rakshit became the owner of the share of the said under-mentioned property.

AND WHEREAS ~~after demise of~~ Lilabati Rakshit was died intestate on 06.03.1997 leaving behind no issue, as a result the said under-mentioned schedule property of Debendra Nath Rakshit and Lilabati Rakshit were vested amongst the aforementioned co-owners equally.

AND WHEREAS on 26-03-1952 Baman Pada Rakshit alias Bamanpada Rakshit died intestate leaving behind his legal heirs Saileshnandini Rakshit-wife, Ashit Rakshit-son and Ashoke Kumar Rakshit - son, who inherited the shares of Bamanpada Rakshit in equal shares. The name of the said Bamanpada Rakshit was recorded as Assessee in the Office of the Kolkata Municipal Corporation in respect of his share being Assessee No.11-028-17-0041-8.

AND WHEREAS the Saileshnandini Rakshit wife of Late Bamanpada Rakshit, died intestate on 26.08.1976 leaving behind her legal heirs of sons viz. Asit Rakshit and Ashoke Kumar Rakshit.

AND WHEREAS the Asit Rakshit died intestate on 02.12.1993 leaving behind his legal heirs Anima Rakshit-wife, Sayantan Rakshit - son, and Sarbani Ghosh - daughter, they became the owner of the proportionate share of owners of under-mentioned schedule property of Late Asit Rakshit.

AND WHEREAS the Ashoke Kumar Rakshit died intestate on 23.09.2006 leaving behind his legal heirs his wife Chaya Rakshit, and two daughters viz. Sarmistha Sen and Sharmila Chatterjee and they became the joint owners of under-mentioned schedule property of Late Ashoke Kumar Rakshit.

AND WHEREAS on 15.11.2007 the said Chaya Rakshit wife of Late Ashoke Kumar Rakshit died intestate leaving behind her two daughters viz. Sarmistha Sen and Sharmila Chatterjee, they became the joint owners

of the under-mentioned proportionate share of schedule property of late Chaya Rakshit.

AND WHEREAS one Dwijapada Rakshit was co-owner of the under-mentioned schedule property and said Dwijapada Rakshit created a Trust in the name of "Dwijapada Rakshit Trust Estate" which has been registered in the Office of the Registrar at the Calcutta Registration Office and recorded in Book No.-1, Volume -150, being Deed No.4263 in the year 1968 and in the said Trust Deed of Dwijapada Rakshit son of Nritya Gopal Rakshit was a Settlor and Dwijapada Rakshit himself was a Trustee and in the said Trust Deed it was particularly mentioned that after the death of Dwijapada Rakshit his wife Smt. Labanyaprobha Rakshit shall be entitled to reside in one bedroom with liberty to use the bath and privy and passage of under-mentioned schedule property during her lifetime and after the death of Smt. Labanyaprobha Rakshit the proportionate share of Dwijapada Rakshit would be vested absolutely to his son Ganendra Nath Rakshit and his heirs.

AND WHEREAS after demise of Ganendra Nath Rakshit his wife Anjali Rakshit became the absolute owner of the property of Ganendra Nath Rakshit and her name was recorded in the Office of the Kolkata Municipal Corporation as Assessee being No.11-028-17-0041-8. On 28.09.2016 the said Anjali Rakshit died intestate leaving behind no issue as a result, the proportionate share of under-mentioned property of Dwijapada Rakshit were vested amongst the other co-owners equally.

AND WHEREAS Sudhir Kumar Rakshit, Sushil Kumar Rakshit and Sisir Kumar Rakshit acquired their right, title and interest by way of Deed of Gift which was registered in the Office of the Sub-Registrar of Sealdah on 02.07.1951 and recorded in Book No.1, Volume No.36 being Deed No.2276 in the year 1951. Between Dwijapada Rakshit, Bamanpada Rakshit and

Debendra Nath Rakshit as "the donors" of under-mentioned schedule property. The said donors transferred their undivided three-twentieth (3/20th) share to "the Donees" viz. Sudhir Kumar Rakshit, Sushil Kumar Rakshit and Sisir Kumar Rakshit. Thereafter they became the co-owner of 1/3rd share each out of their undivided three-twentieth (3/20th) share of under-mentioned undivided schedule property and their names have been recorded as Assessee in the Office of the Kolkata Municipal Corporation being Assessee No.11-028-17-0041-8.

AND WHEREAS after demise of the said Sudhir Kumar Rakshit leaving behind his legal heirs Uma Rakshit - wife, Birendra Kumar Rakshit-son and three daughters viz Kalyani Ghosh, Roma Brahmacharie and Aparna Basu. The said Birendra Kumar Rakshit, Kalyani Ghosh, Roma Brahmacharie and Aparna Basu became the owners of proportionate share of under-mentioned schedule property of Late Sudhir Kumar Rakshit.

AND WHEREAS the Uma Rakshit died intestate on 14.05.2012 leaving behind her legal heirs viz. Birendra Kumar Rakshit-son and three daughters viz Kalyani Ghosh, Roma Brahmacharie and Aparna Basu. The said Birendra Kumar Rakshit, Kalyani Ghosh, Roma Brahmacharie and Aparna Basu became the proportionate share owners of under-mentioned schedule property of late Uma Rakshit.

AND WHEREAS the Sushil Kumar Rakshit died intestate on 02.03.1992 leaving behind his legal heirs Chabi Rakshit-wife and only daughter Smt. Purnima Mitra wife of Mr. Probir Kumar Mitra and they became the joint owners of proportionate share of under mentioned schedule property of late Sushil Kumar Rakshit.

AND WHEREAS the Sisir Kumar Rakshit died intestate on 23.06.1983 leaving behind his legal heirs namely, Dipty Rakshit-wife and Sumitra Mitra-daughter, wife of Mr. Arindam Mitra and they became the joint owners of proportionate share of under-mentioned property of late Sisir Kumar Rakshit.

AND WHEREAS the Dipty Rakshit died intestate on 12.11.2004 leaving behind her only daughter of Sumitra Mitra-who became the owner of proportionate share of under-mentioned property of her mother late Dipty Rakshit.

AND WHEREAS the Chabi Rakshit died intestate on 23.11.2010 leaving behind his only daughter of Smt. Purnima Mitra- wife of Probir Kumar Mitra and she became the owner of proportionate share of under mentioned schedule property of her mother late Chabi Rakshit.

AND WHEREAS the vendors herein have inherited the ownership share, right, title and interest in respect of the premises No.258, Vivekananda Road, P.S.-Beliaghata, (Narkeldanga), Kolkata-700006 from their predecessors-in-interest in the manner aforesaid and are presently co-owners each having an undivided proportionate share in the said premises as follows:-

AND WHEREAS Vendors of these present became the absolute joint owners and are well seized and possessed of the under-mentioned schedule property in their indefeasible estate by way of inheritance free from all encumbrances by amicable possession with other co-owners and they have good marketable title in the schedule property, without any claim, question and dispute in any manner whatsoever.

NOW THIS INDENTURE WITNESSETH in pursuance of the several discussions and in consideration of the total sum of Rs. 97,00,000/- (Rupees Ninety Seven Lakhs) only truly paid by banker's cheque from the purchaser to the vendors as per Memo of consideration below at or immediately before the execution of these presents (the receipt whereof the vendors doth hereby grant, convey and also the receipt written hereunder) admit and acknowledge and of and from the same and every part thereof acquit, release and discharge forever to the said purchaser of the said under-mentioned Schedule property alongwith all facilities wide passage particularly described in the Schedule hereunder written, the Vendors doth hereby grant, convey, sell, transfer, assign and assure unto the purchaser herein **ALL THAT** piece and parcel of Land with structure measuring an area two cottahs and three chittaks be the same a little more or less described in the Schedule hereunder written together with full benefit of passages, ways, water-ways, rights, liberties, privileges and

all manner or easements and appurtenances belonging **AND ALL** the estate right, title and interest claim and demand whatsoever of the vendors into upon the same and every part thereof **TO HAVE AND TO HOLD** the said piece and parcel of Land with building measuring an area of two cottahs and three chittaks be the same a little more or less hereby granted, conveyed, transferred and assigned and intended so to be unto the use of the purchaser herein absolutely and forever free from all encumbrances, mortgage, charges, attachments, liens, lispendent and liabilities whatsoever.

AND THE VENDORS HEREBY COVENENT WITH THE PURCHASER as follows :

- i) **THAT** notwithstanding any acts, deeds or things hereto before done, executed or knowingly suffered to the contrary, the said vendors are now lawfully seized and possessed of the Schedule property free from all encumbrances, attachments or defects in title whatsoever and that the vendors have full power and absolute authority to sell or transfer the said property in the aforesaid manner.
- ii) **THAT** the purchaser will hereafter peacefully and quietly hold, possess the said property without any claim or demand whatsoever from the Vendors or any person claiming through or under the Vendors.
- iii) **FURTHER THAT** the Vendors their heirs, successors, executors, administrators, or assignees, covenants with the Purchaser its successors-in-office, successors-in-interest and assigns, to save harmless indemnify and keep indemnified the Purchaser the heirs, its successors-in-office, successors-in-interest and assigns, free or against all encumbrances, charges and equities whatsoever.

- iv) **THAT** the Vendors their heirs, successors, administrators or assignees further covenant that they shall at the request and the cost of the Purchaser its successors-in-interest or assigns, do or cause to be done or executed all such lawful acts, deeds and things whatsoever for further and more perfectly assuring and conveying the said property or premises measuring an area of two cottahs and three chittaks be the same a little more or less and every part thereof in the manner aforesaid according to the true intent and meaning of this deed.

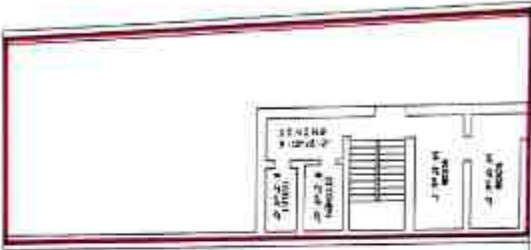

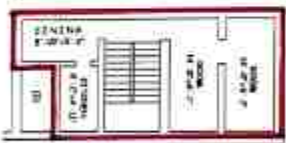
