New Town, Kolkata - 700135, District - North 24-Parganas, West Bengal, all by religion Islam, all by Nationality Indian, all by occupation Cultivations, hereinafter collectively called the <u>VENDORS</u> (which expression shall unless excluded by or repugnant to the context be deemed to include their respective heirs executors administrators representatives and assigns) of the <u>ONE PART</u>;

WHEREAS:
