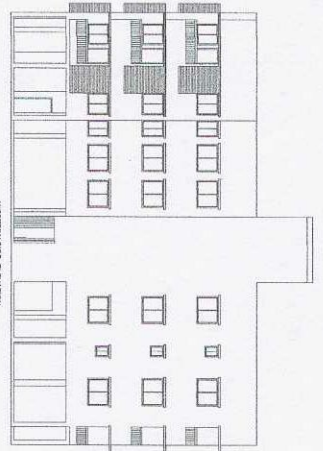
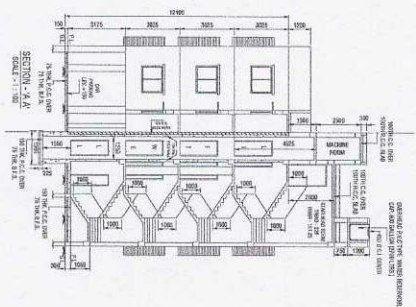


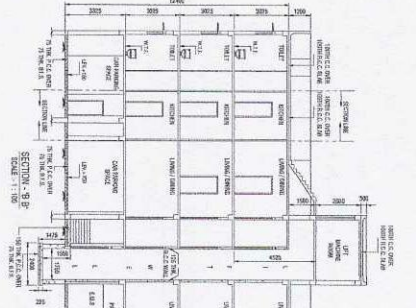
SOUTHERN ELEVATION

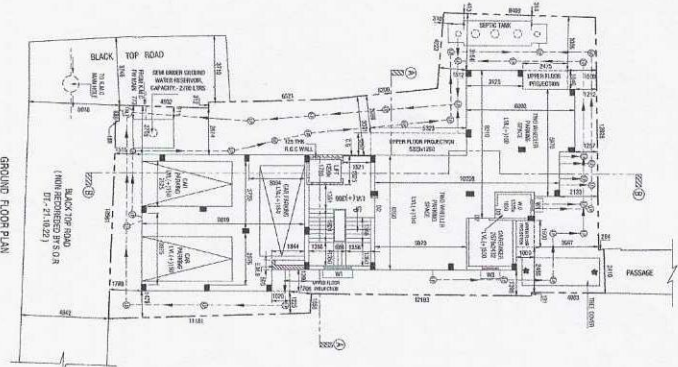
SECTION - A-A

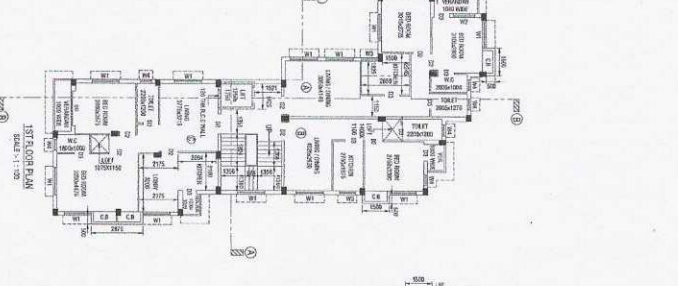

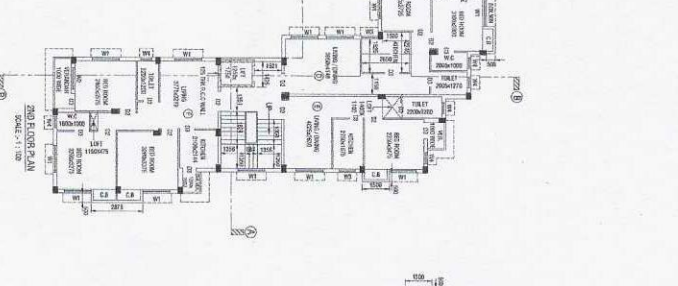

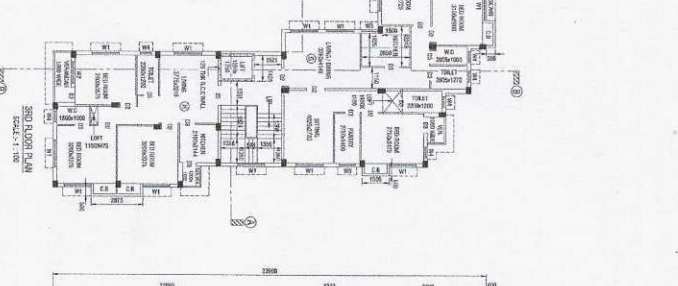
GROUND FLOOR PLAN

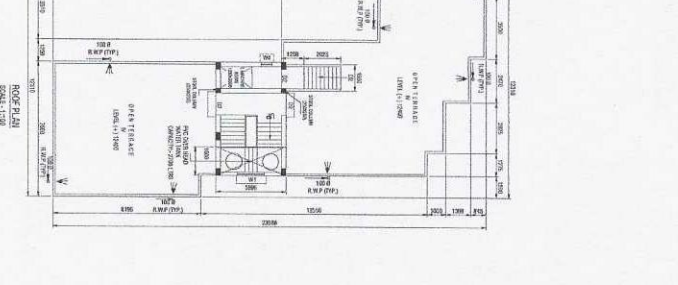
1ST FLOOR PLAN
