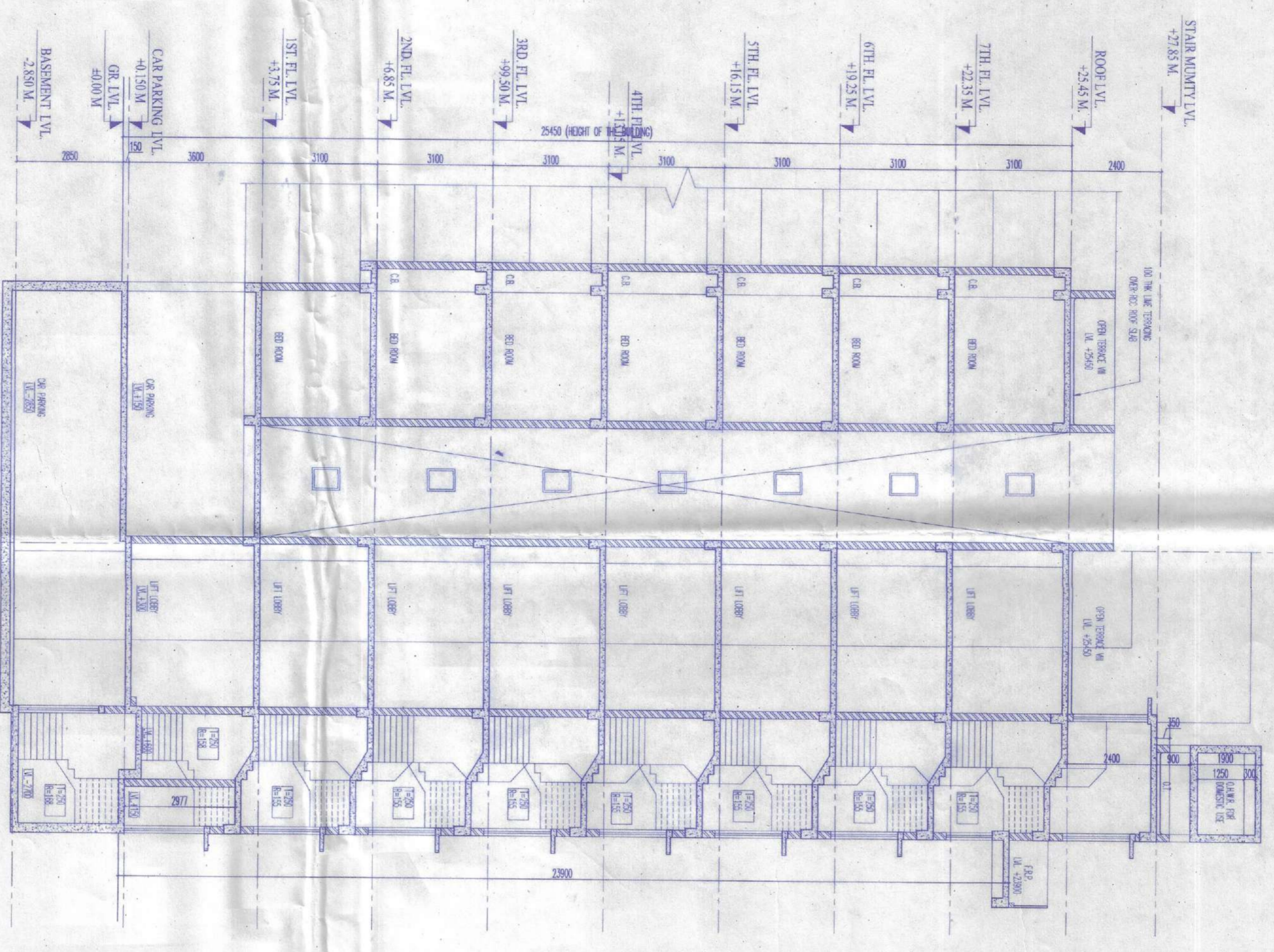
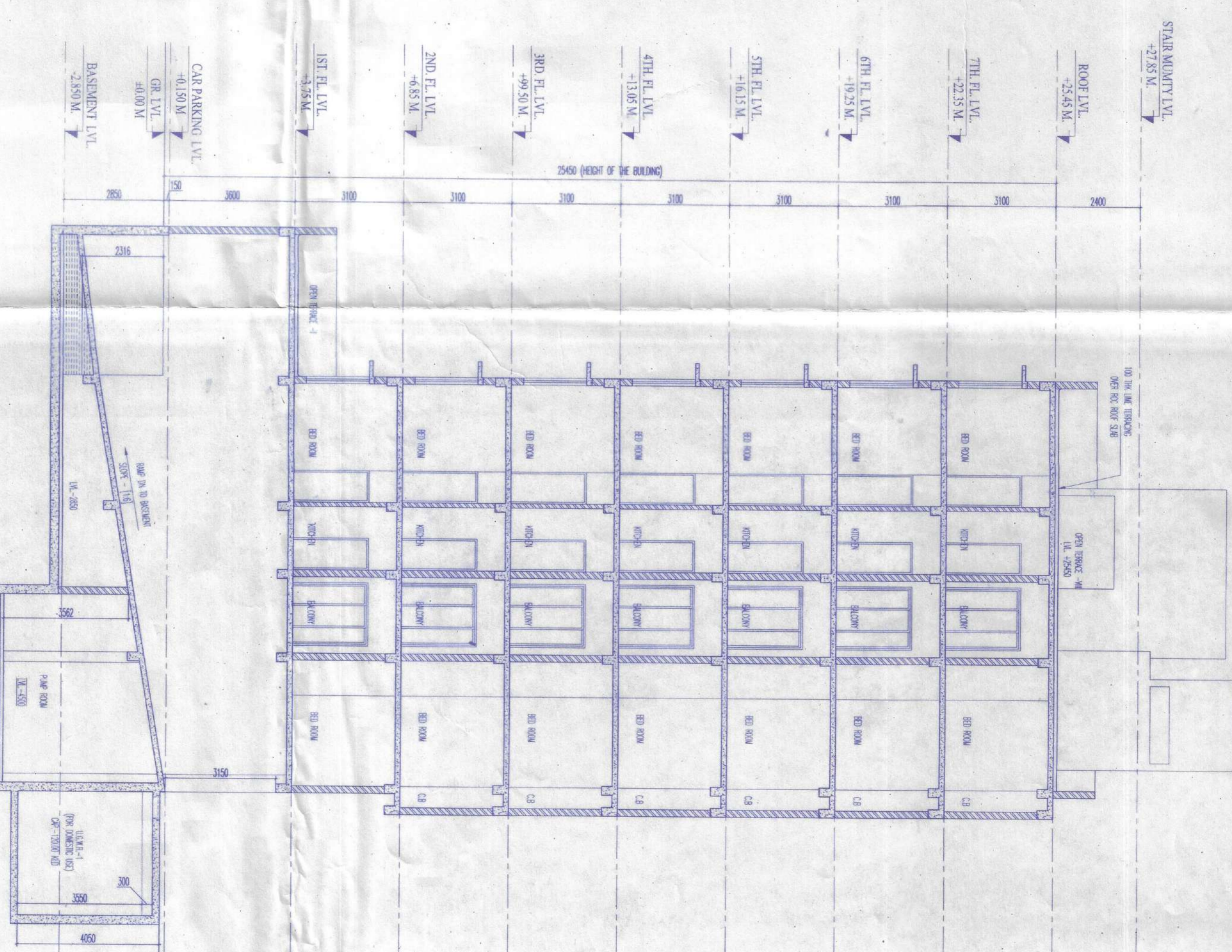


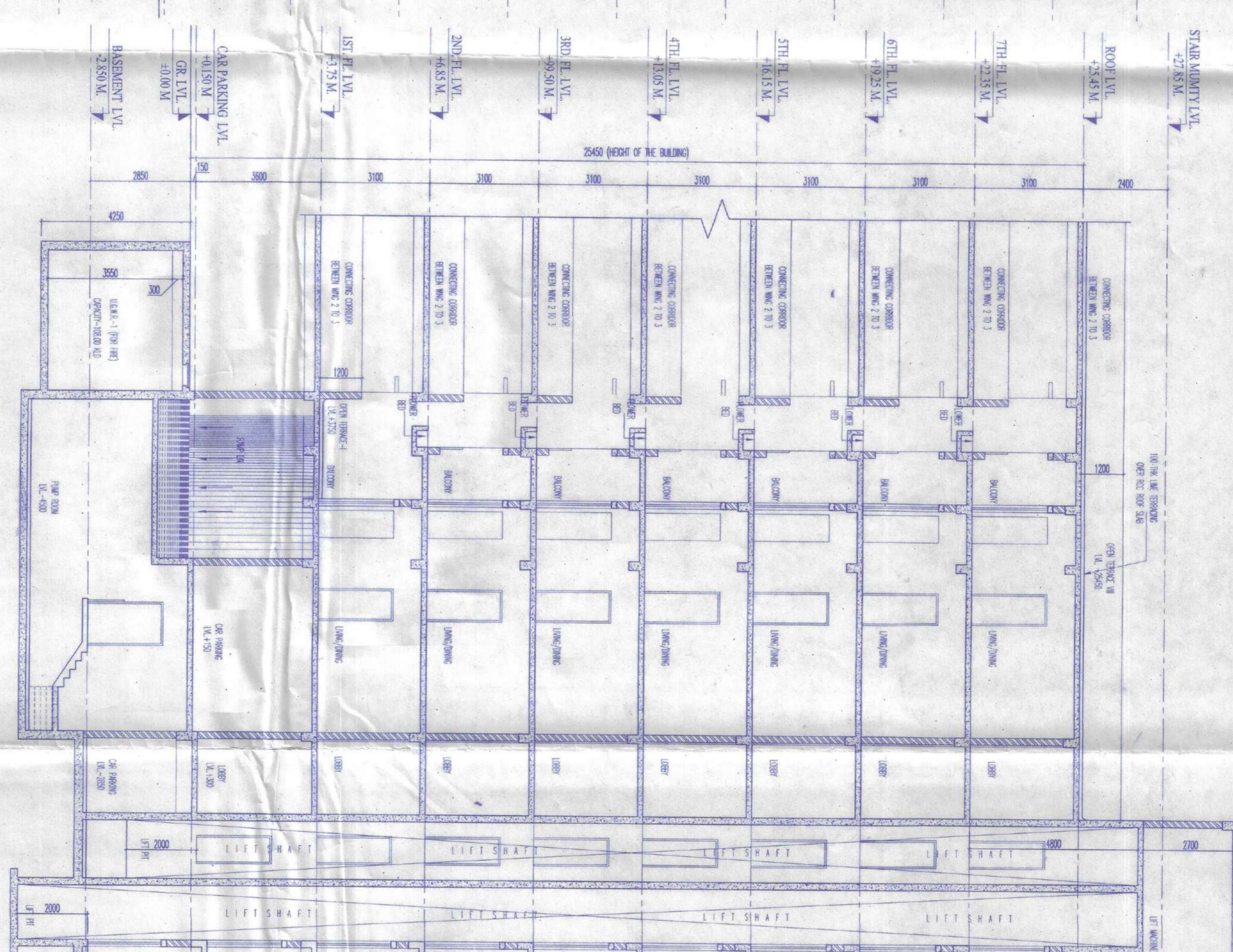
FRONT ELEVATION

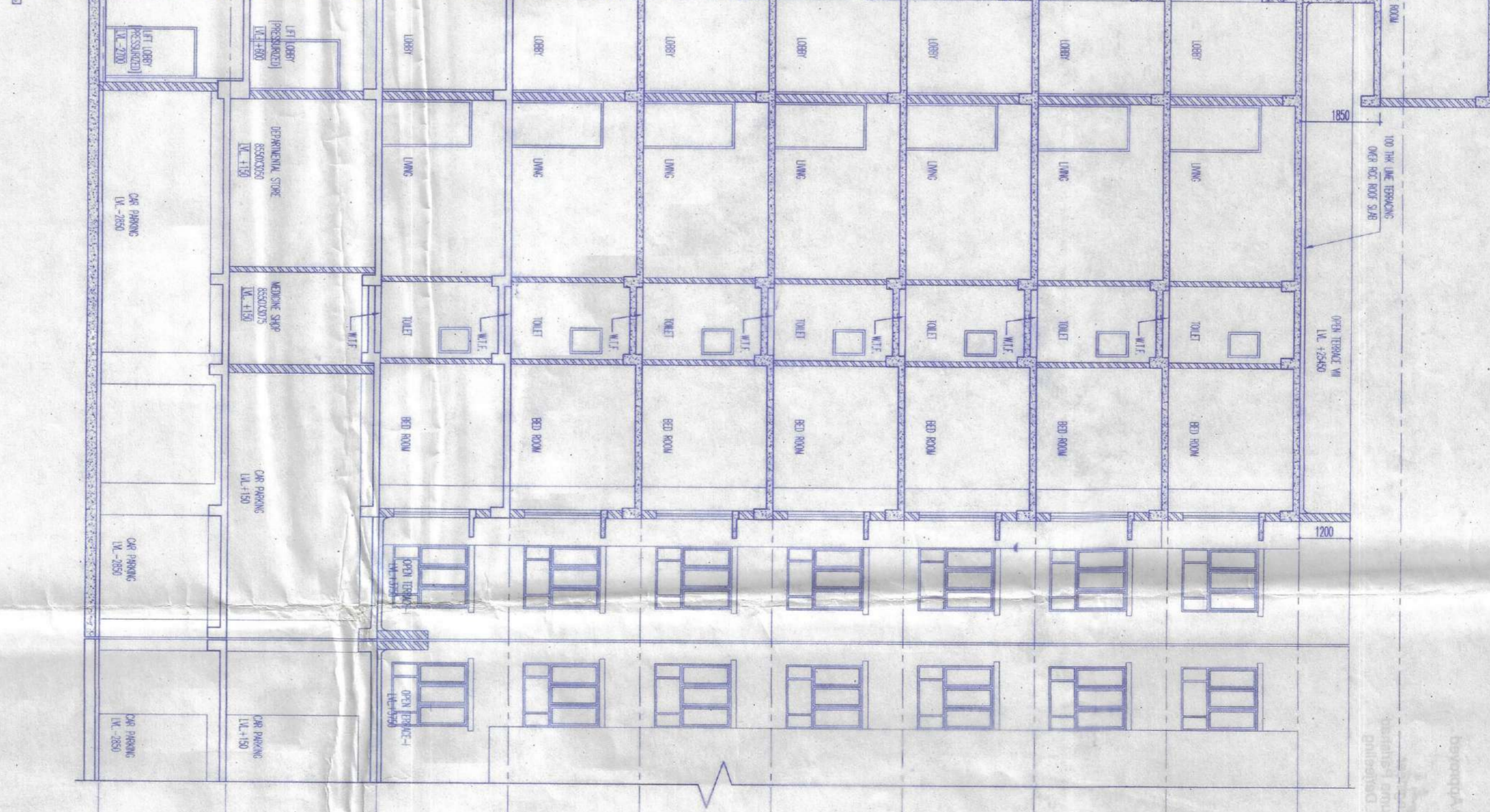
SECTION ON X2-X2
